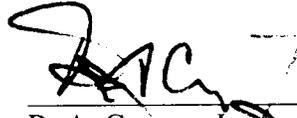

RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE SOLID WASTE DEPARTMENT FOR THE APRIL 29, 2011 "RELAY FOR LIFE" SPONSORED BY AMERICAN CANCER SOCIETY, INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$392.00 TO BE FUNDED FROM THE UNSPENT BALANCE OF THE DISTRICT 1 FY 2008-09 IN-KIND RESERVE FUND

WHEREAS, American Cancer Society, Inc. has requested in-kind services from the Miami-Dade Solid Waste Department for the April 29, 2011 "Relay for Life" in an amount not to exceed \$392.00 (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, the "Relay for Life" is a fundraiser to benefit the American Cancer Society and aims to, among other things, raise community awareness regarding the fight against cancer; and

WHEREAS, American Cancer Society, Inc. is a not-for-profit organization; and

WHEREAS, the "Relay for Life" is a small event, as that term is defined on the attached Fee Waiver/In-kind Service Application, and \$392.00 of the in-kind services shall be funded from the unspent balance of the District 1 FY 2008-09 In-kind Reserve Fund,

Subject: District Specific In-Kind Request Recommendation

Recommendation

The Office of Management and Budget (OMB) reviewed the attached in-kind request and recommends this item move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for funding of this request.

Background

A retroactive waiver for in-kind services has been requested by a not-for-profit organization, American Cancer Society, Inc. for their "Relay for Life" event held on April 29, 2011.

In-kind services have been requested in an amount not to exceed \$392 from the Miami-Dade Solid Waste Department for the use of E-Z Carts. This event will be funded from the unspent balance of the District 1 FY 2008-09 in-kind reserve fund.

In FY 2010-11, the American Cancer Society, Inc., received \$6,000 from District 7 Discretionary reserve funds, \$500 from District 3 Office funds, \$140 from District 4 Office funds, \$500 from District 5 Office funds, and \$7,500 from District 12 Office funds.
