RESOLUTION AUTHORIZING ALLOCATION OF FEES COLLECTED FOR ISSUING PARKING PERMITS FOR PERSONS TRANSPORTING YOUNG CHILDREN AND STROLLERS TO LAUREN'S KIDS, INC. IN THE AMOUNT OF \$30,000.00, THE CENTER FOR FAMILY AND CHILD ENRICHMENT, INC. IN THE AMOUNT OF \$35,000.00 AND THE YMCA OF GREATER MIAMI IN THE AMOUNT OF \$35,000.00

**WHEREAS**, Ordinance No. 94-104 provides that one-third of fees collected for issuing parking permits for persons transporting young children and strollers shall be distributed to private not-for-profit, non-denominational agencies providing services for severely abused or neglected children; and

**WHEREAS**, Lauren's Kids, Inc. is a private 501(c)(3) not-for-profit, non-denominational entity whose mission is to prevent sexual abuse of minors through educating children and adults about sexual predators, support survivors and their families in post-disclosure recovery and promote awareness of sexual abuse laws; and

**WHEREAS**, the Center for Family and Child Enrichment, Inc. is a private 501(c)(3) not-for-profit, non-denominational entity whose mission is to, among other things, provide services for severely abused or neglected children; and

**WHEREAS**, the YMCA of Greater Miami is a private 501(c)(3) not-for-profit, non-denominational entity which offers programs which, among other things, benefit children who have been severely abused or neglected; and

**WHEREAS**, the Commission believes that it is in the best interest of the citizens of Miami-Dade County to provide funding to these entities,

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA**, that the County Mayor or

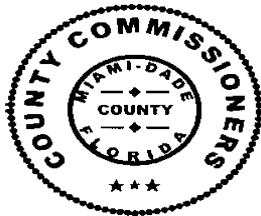
Mayor's designee is hereby directed to distribute funds collected from the issuance of parking permits for persons transporting young children and strollers as follows:

Lauren's Kids, Inc.	\$30,000.00
Center for Family and Child Enrichment, Inc.	\$35,000.00
YMCA of Greater Miami	\$35,000.00.
