



RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE PARKS, RECREATION, AND OPEN SPACES DEPARTMENT FOR THE OCTOBER 15, 2011 "HISPANIC HERITAGE NIGHT 2011" EVENT SPONSORED BY GLADEVIEW BAPTIST CHURCH OF MIAMI, INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$3,820.00 TO BE FUNDED FROM THE DISTRICT 11 FY 2011-12 IN-KIND RESERVE FUND

**WHEREAS**, Gladeview Baptist Church of Miami, Inc., has requested in-kind services from the Parks, Recreation, and Open Spaces Department for the October 15, 2011 "Hispanic Heritage Night 2011" event in an amount not to exceed \$3,820.00 (see attached Fee Waiver/In-kind Service Application); and

**WHEREAS**, the purpose of the "Hispanic Heritage Night 2011" event is to, among other things, celebrate cultural differences and enjoy folkloric dances and typical foods of the featured Hispanic countries; and

**WHEREAS**, Gladeview Baptist Church of Miami, Inc., is a not-for-profit organization; and

**WHEREAS**, the "Hispanic Heritage Night 2011" is a district event, as that term is defined in the attached Fee Waiver/In-kind Service Application, and \$3,820.00 of the in-kind services shall be funded from the District 11 FY 2011-12 In-Kind Reserve Fund,




