This item was amended at the November 8, 2011 Internal Management and Fiscal Responsibility Committee Meeting to reduce Miami-Dade Transit's allocation under Item 4 - Towing Services (County Vehicles) from \$700,000 to \$400,000.

Recommendation

It is recommended that the Board of County Commissioners approve the attached competitive contract modifications.

Contract amounts and department allocations represent the maximum spending authority based on past utilization. This action does not guarantee that the total contract amount/value will be expended by County departments and/or agencies.

Scope

The impact of the items in the accompanying Competitive Contract Modifications Package is countywide in nature.

Fiscal Impact/Funding Source

Funding will be expended only if departmental budgets can support the expenditures approved in their Resource Allocation Plan adopted annually by the Board. There is no additional fiscal impact beyond what is stated on the individual items in this package. Allocations have been rounded consistent with standard auditing practices.

Track Record/Monitor

There are no known performance issues with the vendors recommended for award in the Competitive Contract Modifications Package. Each department's contract manager is reflected in the Competitive Contract Modifications Package.

Delegated Authority

If this item is approved, the County Mayor or County Mayor's designee will have the authority to exercise, in their discretion, subsequent options-to-renew (OTR) and extend contracts for purchase of goods and services in accordance with the terms and conditions of the each contract.

COMPETITIVE CONTRACT MODIFICATIONS

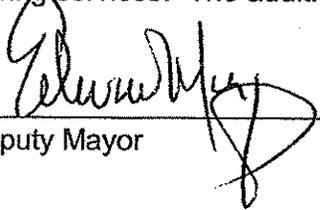
A competitive contract modification is an award of a supplemental allocation for goods or services within the scope of the original contract award.

Item 1: Medical and Industrial Gases is to modify this contract to add an allocation funded by MDT Operating funds to allow the Miami-Dade Transit Department to purchase medical and industrial gases. The additional amount being requested is **\$5,000**.

Item 2: Traffic Cones is to modify this contract to add an allocation funded by MDT Operating funds to allow the Miami-Dade Transit Department to purchase traffic cones. The additional amount being requested is **\$6,000**.

Item 3: Various Laboratory Instruments is to modify this contract for additional spending authority to allow the Miami-Dade Police Department to continue purchase of lab instruments, equipment and related maintenance services. The additional amount being requested is **\$98,000**.

Item 4: Towing Services (County Vehicles) is to modify this contract to add an allocation funded by MDT Operating funds to allow the Miami-Dade Transit Department to purchase towing services. The additional amount being requested is **\$400,000**.



Performance Data: Kauff's of Miami, Inc.: During this contract's second option-to-renew period, the County discovered errors with invoicing. This firm overcharged the County on two occasions for towing services. The vendor agreed to cancel the incorrect invoices and issued new invoices with correct amounts.

The following performance issues involve vendors awarded a contract

under RFQ97, Police Towing and which are recommended for this contract. These issues have been successfully closed out or corrected.

Westbrook Motors, Inc

While conducting a site inspection due to the sale of the company, the Miami-Dade Police Department discovered that Westbrook did not have sufficient inside storage space to comply with requirements of the County contract. Westbrook had an agreement with the City of Hialeah that required the same amount of inside storage spaces as the County contract. The City of Hialeah relinquished Westbrook from their agreement after the new owners agreed that the inside storage space was to be used solely by Miami-Dade County.

Kauff's of Miami, Inc.

MDPD issued a warning to the vendor for several violations including overcharging citizens \$13.50 in towing charges per citation. Additionally, the vendor did not issue certified mail to violators as required, creating a delay in issuance of owner notification letters. The vendor acknowledged the violations and issued refunds to the citizens that were overcharged.

A-1 Redland Economy Towing

MDPD issued a warning to the vendor for overcharging citizens for citations issued. The overcharges totaled \$127.00. The vendor acknowledged the violations and issued refunds to the citizens that were overcharged.
