Recommendation

It is recommended that the Board of County Commissioners (Board) approve this Contract Renewal and Amendment No. 1 (as attached) for Construction Contract No. W-897, Divisions 1 and 2, pursuant to Section 2-8.1 of the Code of Miami-Dade County to H & R Paving, Inc. This second and last renewal was prepared by the Miami-Dade Water and Sewer Department (WASD) for an additional year in the amount of \$340,200, making for a total dollar amount awarded of \$1,360,800.

The initial contract award was approved by the Board via Resolution No. R-708-08 in June 2008. The resolution delegated to the County Mayor or his designee the authority to exercise two 1-year renewals. The first renewal was exercised timely and expired on August 4, 2011. The second and final renewal was not exercised timely. Therefore, this amendment to the original contract term was prepared and agreed to by the Contractor and the County. The amendment entitled "Contract Renewal and Amendment No. 1" (Contract Renewal) authorizes WASD to exercise the second and final renewal for one-year notwithstanding the expiration date of the initial contract term under the same terms and conditions, and at the same unit prices of the original contract.

Scope

This Contract Renewal has countywide impact. It involves a general contracting firm providing services necessary to adjust the elevations of water main and fire hydrant valve boxes, sanitary sewer and water valve manholes throughout the county prior to final paving on roadwork done by the Florida Department of Transportation (FDOT) or other municipalities. The work also includes, but is not limited to, installing fire hydrant guard posts, constructing concrete slabs for fire hydrants, and all other associated work.

The project is divided into two divisions, each of which is considered a separate contract: Division 1 consists of performing the work at locations anywhere within the limits of Miami-Dade County north of, and on Flagler Street; and Division 2 consists of performing the work at locations anywhere within the limits of Miami-Dade County south of Flagler Street.

This is a non-exclusive contract, and as such, the Department may issue other similar contracts for this type of work, and therefore does not guarantee that the full amount of the contract work as listed in the proposal will be issued to the contractor. The actual amount of work orders assigned will be the prerogative of WASD in its sole discretion and dependent only upon its needs.

This Contract Renewal is being awarded for a dollar amount up to \$340,200 (\$170,100 per division) for a 12-month period and will terminate upon the depletion of that amount, or the expiration of the 12-month period, whichever occurs first. All services provided during the renewal period shall be

performed under the same terms and conditions and at the same unit prices provided in the original contract. Upon completion of this Contract Renewal no subsequent renewals will be executed.

Fiscal Impact/Funding Source

This Contract Renewal has a one year financial commitment in the amount of \$340,200 which will be funded by WASD Operating Revenue and the Fire Hydrant Funds. The project will have an impact on the Department's FY11-12 budget.

Track Record/Monitor

According to the Firm History Report as provided by the Department of Small Business Development, H & R Paving, Inc. has received thirty-two (32) contracts valued at \$47,458,219 from Miami-Dade County in the last five years. The Office of Capital Improvements CIIS database contains 127 evaluations from county departments for H & R Paving, Inc. with an average rating of 3.0 which represent satisfactory performance. The day to day responsibilities for this project are the responsibility of Mr. Raul Caballero, W & S Construction Project Supervisor 1, Miami-Dade Water and Sewer Department.

Background

This project is necessary to adjust the elevations of water main and fire hydrant valve boxes, sanitary sewer and water valve manholes throughout the county prior to the final paving on roadwork done by FDOT or other municipalities.

modified as follows:


1. The Contract amount is increased by \$340,200 for the second (and last) one-year renewal period,

provided in the Contract, as if this Contract Renewal was timely exercised.

The County does not guarantee that the full amount of the Contract will be issued to, or paid to the contractor. The actual amount of work orders assigned is also a prerogative of the County in its sole discretion and dependent only upon its needs.

THE CONDITION OF THIS BOND is that if Principal:

1. Performs all work due under the Contract, including but not limited to guarantees, warranties, and the curing of latent defects, said Contract being made a part of this bond by reference; and in the times and in the manner prescribed in the Contract, including any and all damages for delay; and
2. Promptly makes payments to all claimants, as defined in Section 255.05 (1), Florida Statutes, supplying Principal with labor, materials, or supplies, used directly or indirectly by Principal in the prosecution of the work provided for in the Contract; and
3. Pays County for all losses, damages, including damages for delay, expenses, costs and attorney's fees, including appellate proceedings, that County sustains because of a default by Principal under the Contract, including but not limited to a failure to honor all guarantees and warranties or to cure latent defects in its work or materials within 5 years after completion of the work under the Contract; and
4. Performs the guarantee of all work and materials furnished under the Contract for the time specified in the Contract, including all warranties and curing all latent defects within 5 years after completion of the work under the Contract;

then this bond is void, otherwise it remains in full force.

If no specific periods of warranty are stated in the Contract for any particular item or work, material or equipment, the warranty shall be deemed to be a period of one (1) year from the date of final acceptance by the County. This Bond does not limit the County's ability to pursue suits directly with the Principal seeking damages for latent defects in materials or workmanship, such actions being subject to the limitations found in Section 95.11(3)(c), Florida Statutes.

Any changes in or under the Contract Documents, and compliance or noncompliance with any formalities connected with the Contract or the changes, do not affect the Surety's obligation under this Bond.






