RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE PARKS, RECREATION, AND OPEN SPACES DEPARTMENT FOR THE NOVEMBER 12, 2011 "WILD WALK" EVENT SPONSORED BY GREATER MIAMI YOUTH FOR CHRIST, INC., A NON-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$400.00 TO BE FUNDED FROM THE DISTRICT 8 FY 2011-2012 IN-KIND RESERVE FUND

**WHEREAS**, Miami Youth For Christ, Inc., has requested in-kind services from the Parks, Recreation, and Open Spaces Department for the November 12, 2011 "Wild Walk" event in an amount not to exceed \$400.00 (see attached Fee Waiver/In-kind Service Application); and

**WHEREAS**, the purpose of the "Wild Walk" event is to raise funds to support various initiatives including, but not limited to, afterschool programs, outreach to young people who are in residential facilities due to abuse or illegal activities and educational programs designed to promote healthy relationships, life skills and creativity; and

**WHEREAS**, Miami Youth For Christ, Inc., is a not-for-profit organization; and

**WHEREAS**, the "Wild Walk" event is a small event, as that term is defined in the attached Fee Waiver/In-kind Service Application, and \$400.00 of the in-kind services shall be funded from the District 8 FY 2011-2012 In-Kind Reserve Fund,




