



RESOLUTION NO. R-15-12

RESOLUTION RENAMING "SW 118TH PLACE" AND "SW 118TH PATH" SHOWN ON THE PLAT OF MYSTIC FOREST SECOND ADDITION, RECORDED IN PLAT BOOK 165, AT PAGE 67, AS "SW 120TH AVENUE" AND "SW 120TH COURT" RESPECTIVELY

WHEREAS, on September 26, 2006, this Board approved Resolution No. 1053-06 approving the plat of Mystic Forest Second Addition; and

WHEREAS, the plat of Mystic Forest Second Addition, recorded in Plat Book 165, Page 67, of the Public Records of Miami-Dade County, Florida, which was filed on October 30, 2006, shows certain private roads within said plat designated as SW 118th Place and SW 118th Path; and

WHEREAS, SW 118th Place and SW 118th Path within this private community were erroneously named contrary to requirements for the numerical naming of roads pursuant to the Code of Miami-Dade County; and

WHEREAS, a request has been made to rename SW 118th Place and SW 118th Path to be consistent with the Code based on problems being encountered by some of the residents with their addresses that were assigned with the existing street designations as shown on the plat; and

WHEREAS, these road renamings are located in County Commission District 10,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Having considered this matter at a public hearing, amends its prior Resolution No. 1053-06 to rename “SW 118th Place” as “SW 120th Avenue” and “SW 118th Path” as “SW 120th Court” as shown on the plat of Mystic Second Addition.

Section 2. Directs the Clerk of the Board to send certified copies of this Resolution to the United States Postal Service, the Traffic Signals and Signs Division of the Public Works and Waste Management Department, the Land Development/Right-of-Way Division of the Public Works and Waste Management Department, the Miami-Dade Police Department, and the Miami-Dade Fire Rescue Department.

The Prime Sponsor of the foregoing resolution is Sen. Javier D. Souto. It was offered by Commissioner **Sen Javier D. Souto**, who moved its adoption. The motion was seconded by Commissioner **Lynda Bell** and upon being put to a vote, the vote was as follows:
