RESOLUTION APPROVING THE CITY OF HIALEAH  
CODESIGNATION OF WEST 13 LANE FROM WEST  
44 PLACE TO WEST 47 PLACE AND WEST 47 PLACE FROM  
WEST 13 LANE TO WEST 12 AVENUE AS "GUS MACHADO  
WAY"

**WHEREAS**, on December 19, 2011, the Mayor and City Council of the City of Hialeah passed Resolution No. 11-133, which codesignated West 13 Lane from West 44 Place to West 47 Place and West 47 Place from West 13 Lane to West 12 Avenue as "Gus Machado Way," in recognition of Gus Machado's contributions to the City of Hialeah, a copy of which is attached and incorporated by reference; and

**WHEREAS**, Gus Machado has been a business owner, philanthropist and community leader in the City of Hialeah since 1982; and

**WHEREAS**, in 2003, Machado was a founder of the U.S.-Cuba Democracy PAC, a political group that promotes an unconditional transition in Cuba to democracy, the recognition of the fundamental human and civil rights and free markets; and

**WHEREAS**, in 2008, Machado created the "Gus Machado Family Foundation", a not-for-profit organization dedicated to philanthropy, voluntarism and making grants to worthy causes; and

**WHEREAS**, West 13 Lane from West 44 Place to West 47 Place and West 47 Place from West 13 Lane to West 12 Avenue are city streets located in the City of Hialeah; and

**WHEREAS**, the City of Hialeah wants the County to install signage indicating this co-designation on County street signs and traffic signal masts arms; and

WHEREAS, this codesignation is located in County Commission District 13,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

**Section 1.** Approves the City of Hialeah's codesignation of West 13 Lane from West 44 Place to West 47 Place and West 47 Place from West 13 Lane to West 12 Avenue as "Gus Machado Way."

**Section 2.** Directs the Clerk of the Board to send certified copies of this Resolution to the Mayor of the City of Hialeah, the United States Postal Service, the Traffic Signals and Signs Division of the Public Works and Waste Management Department, the Land Development/ Right-of-Way Division of the Public Works Department, the City of Hialeah Police Department and the City of Hialeah Fire Rescue Department.

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, DECLARING NO OBJECTION AND SUPPORTING THE CODESIGNATION BY THE CITY OF HIALEAH HISTORIC PRESERVATION BOARD, DESIGNATING WEST 13 LANE, FROM WEST 44 PLACE TO WEST 47 PLACE, ALONG WEST 47 PLACE, FROM WEST 13 LANE TO WEST 12 AVENUE HIALEAH, FLORIDA, AS "GUS MACHADO WAY;" IN HONOR OF THE OUTSTANDING SERVICE OF GUS MACHADO TO THE CITY OF HIALEAH AND ITS RESIDENTS, WITH THE COST OF SIGNAGE TO BE PAID BY THE APPLICANT

**WHEREAS**, the co-designation of that portion of West 13 Lane, from West 44 Place to West 47 Place, along West 47 Place, from West 13 Lane to West 12 Avenue, as "GUS MACHADO WAY", presently unnamed, is in honor of the outstanding service of Mr. Gus Machado to the City of Hialeah and its residents; and

**WHEREAS**, Gus Machado has been a business owner, philanthropist and community leader of the City of Hialeah since 1982; and

**WHEREAS**, Gus Machado has served his community as an outstanding entrepreneur, community partner, citizen, father, husband, and grandfather; and

**WHEREAS**, Gus Machado was born in Cuba, where his love for his native country and entrepreneurial spirit flourished into what later became a distinguished career in the automobile trade in his new homeland; where he has held the most prestigious titles and received the highest accolades as a Ford Automobile dealer, such as the Blue Oval Certification status and the President's Award from Ford Motor Company; all these factors have allowed him to fulfill the passion he felt for dedicated service to his community; and

**WHEREAS**, in 2003 Mr. Machado was a founder of the U.S.-Cuba Democracy PAC, a group created to and

**WHEREAS**, Gus Machado's love for his native country and dedication to those in need along with his lovely wife, Lilliam Machado, has been evident in his leadership with dozens of charities and organizations; Throughout the years, Gus Machado has dedicated his time, efforts, and financial support to his businesses and community. 


