RESOLUTION NO. R-66-12

RESOLUTION DIRECTING COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO WAIVE FEES FOR ELECTORS SEEKING TO REVIEW THEIR OWN ABSENTEE BALLOTS; TO PROVIDE INFORMATION OR DIRECTION TO ELECTORS WHO HAVE BEEN THE VICTIM OF IMPROPER OR CRIMINAL ACTIVITY WITH REGARDS TO THEIR ABSENTEE BALLOTS TO ALLOW THEM TO LEGALLY CAST A VOTE AND REPORT ANY CRIMINAL ACTIVITIES TO THE APPROPRIATE AUTHORITIES; AND REQUIRING A REPORT TO THE BOARD WITHIN SIXTY (60) DAYS

**WHEREAS**, the right to vote is fundamental to democratic government; and

**WHEREAS**, confidence by the electorate that each vote will be counted and any ballots cast, including absentee ballots, will not be altered or stolen is essential to ensure that the right to vote is maintained; and

**WHEREAS**, electors who have made requests to the Miami-Dade County Department of Elections to review their own absentee ballot envelopes have ~~>>either<<~~<sup>1</sup> been charged fees ~~>>or have been threatened to be charged fees after fifteen (15) minutes<<~~ in accordance with Chapter 119 of the Florida Statutes (the "Public Records Law"); and

**WHEREAS**, the imposition of fees ~~>>or the threat to impose fees<<~~ in accordance with the Public Records Law to individuals requesting to review their own absentee ballot envelopes acts to discourage voters from investigating improper or criminal activity regarding their absentee ballots and reporting such activities to the appropriate authorities; and

WHEREAS, the Board of County Commissioners desires to encourage electors to investigate and pursue cases of improper or illegal activities regarding their absentee ballots and enable the electors to easily pursue such claims,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board directs the County Mayor or County Mayor's designee to waive any fees established pursuant to the Public Records Law or any other similar fee for electors seeking to review their own absentee ballot. This Board further directs the County Mayor or County Mayor's designee to take all reasonable steps to provide information or direction to electors who have been the victim of improper or criminal activity with regards to their absentee ballots to allow them to legally cast a vote>> if possible<< and report any criminal activities to the appropriate authorities for further investigation and potential prosecution. The County Mayor or County Mayor's designee shall report all steps taken to implement this resolution to the Board of County Commissioners within sixty (60) days of the effective date of this resolution.

The Prime Sponsor of the foregoing resolution is Commissioner Rebeca Sosa. It was offered by Commissioner **Dennis C. Moss**, who moved its adoption.

The motion was seconded by Commissioner **Jean Monestime** and upon being put to a vote, the vote was as follows:


