

RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE PARKS, RECREATION, AND OPEN SPACES DEPARTMENT FOR THE NOVEMBER 20, 2011 "THANKSGIVING FESTIVAL" EVENT SPONSORED BY CURLEY'S HOUSE OF STYLE, INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$1,800.00 TO BE FUNDED FROM THE DISTRICT 3 FY 2011-12 IN-KIND RESERVE FUND

**WHEREAS**, Curley's House of Style, Inc., has requested in-kind services from the Parks, Recreation, and Open Spaces Department for the November 20, 2011 "Thanksgiving Festival" event in an amount not to exceed \$1,800.00 (see attached Fee Waiver/In-kind Service Application); and

**WHEREAS**, the "Thanksgiving Festival" celebrates the holiday and provides free food and entertainment to members of the public; and

**WHEREAS**, Curley's House of Style, Inc., is a not-for-profit organization; and

**WHEREAS**, the "Thanksgiving Festival" event is a district event, as that term is defined in the attached Fee Waiver/In-kind Service Application, and \$1,800.00 of the in-kind services shall be funded from the District 3 FY 2011-12 In-Kind Reserve Fund,


