RESOLUTION NO. R-255-12

RESOLUTION CODESIGNATING NW 62ND AVENUE FROM
PERIMETER ROAD TO NW 29TH STREET AS "RICARDO
MADAN WAY"

WHEREAS, Ricardo Madan was born in Cuba on Christmas Day in the year 1912; and

WHEREAS, while attending the University of Havana he was involved with the ABC movement in assisting to overthrow the Machado dictatorship, was subsequently appointed Consul to Puerto Rico at the early age of 24; and

WHEREAS, upon his return to Cuba, he joined the Cuban Customs Service and later became a customs broker and started his own business running cargo flights between Havana, Miami, Key West, and New York; and

WHEREAS, during the 1950's, Ricardo Madan was repeatedly imprisoned as a political prisoner and later exiled to Mexico due to his opposition to the dictatorship of Fulgencio Batista in Cuba, and was forced to permanently relocate with his family to Miami in 1957 because of his involvement in an attempt to overthrow the Batista regime; and

WHEREAS, in the early 1970's, Ricardo Madan founded, along with Hernan and Jorge Landa, one of the first cargo handling companies in Miami specializing in loading jet freighters, along with providing roller flatbed trucks for transportation of airline pallets between the terminals and the runway; and

WHEREAS, in the early 1980's, he was one of the founders of the Miami Medical Team, which originally provided the Nicaraguan Contra freedom fighters medical assistance and

today continues to provide non-profit humanitarian medical relief and assistance around the world; and

WHEREAS Ricardo Madan passed away on January 28, 2010 at the age of 97; and

WHEREAS, NW 62nd Avenue from Perimeter Road to NW 29th Street is a County road located in unincorporated Miami-Dade County; and

WHEREAS, this Board would like to honor Ricardo Madan with this codesignation; and

WHEREAS, this proposed codesignation is located in County Commission District 6,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Having considered this matter at a public hearing, codesignates NW 62nd Avenue from Perimeter Road to NW 29th Street as “Ricardo Madan Way”.

Section 2. Directs the Clerk of the Board to transmit a certified copy of this resolution to the United States Postal Service, the Traffic Signals and Signs Division of the Public Works and Waste Management Department and Land Development/Right-of-Way Division of the Public Works and Waste Management Department, the Miami-Dade Police Department, and the Miami-Dade Fire Rescue Department.

The Prime Sponsor of the foregoing resolution is Commissioner Rebeca Sosa. It was offered by Commissioner **Rebeca Sosa**, who moved its adoption. The motion was seconded by Commissioner **Audrey Edmonson** and upon being put to a vote, the vote was as follows:
