



RESOLUTION APPROVING THE CODESIGNATION OF THE  
INTERSECTION OF WEST 37TH STREET AND WEST 7TH  
COURT BY THE CITY OF HIALEAH AS "CIRO M. SIGLER  
STREET"

**WHEREAS**, on August 9, 2011, the City Council of the City of Hialeah adopted Resolution No. 11-76, which designated the intersection of West 37th Street and West 7th Court as "Ciro M. Sigler Street," in recognition of his dedication and service to the City of Hialeah Parks and Recreation Department; and

**WHEREAS**, a copy of this Resolution of the City of Hialeah is attached hereto and incorporated by reference; and

**WHEREAS**, Ciro M. Sigler immigrated to the United States from Cuba at the age of 10, and resided in Hialeah most of his life; and

**WHEREAS**, Ciro M. Sigler grew up playing baseball in the City's parks and later worked as a baseball coach in those same parks; and

**WHEREAS**, Mr. Sigler worked for the City of Hialeah Parks and Recreation Department from 1978 to 1982; and

**WHEREAS**, on March 1, 1991, Ciro M. Sigler was tragically and fatally shot by a disgruntled employee that he supervised at Alamo Rent-A-Car; and

**WHEREAS**, the intersection of West 37th Street and West 7th Court are city-maintained streets located in the City of Hialeah; and

**WHEREAS**, the City of Hialeah wants the County to install signage indicating this codesignation on County-maintained street signs and traffic signal masts arms; and

**WHEREAS**, this intersection is located in County Commission District 13,

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA,** that this Board:

**Section 1.** Approves the City of Hialeah codesignation of the intersection of West 37th Street and West 7th Court as “Ciro M. Sigler Street.”

**Section 2.** Directs the Clerk of the Board to send certified copies of this Resolution to the City Manager of the City of Hialeah, the United States Postal Service, the Traffic Signals and Signs Division of the Public Works and Waste Management Department and Land Development/Right-of-Way Division of the Public Works and Waste Management Department, the City of Hialeah Police Department, and the City of Hialeah Fire Rescue Department.

The Prime Sponsor of the foregoing resolution is Commissioner Esteban L. Bovo, Jr. It was offered by Commissioner **Audrey Edmonson**, who moved its adoption. The motion was seconded by Commissioner **Jean Monestime** and upon being put to a vote, the vote was as follows:

RESOLUTION NO. 11-76

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA APPROVING THE CO-DESIGNATION OF THE INTERSECTION OF WEST 37 STREET AND WEST 7 COURT, HIALEAH, FLORIDA, AS "CIRO M. SIGLER STREET", IN HONOR AND RECOGNITION OF HIS DEDICATION AND SERVICE FOR THE CITY OF HIALEAH PARKS AND RECREATION DEPARTMENT, WITH THE COST OF SIGNAGE TO BE PAID BY THE CITY.

**WHEREAS**, the co-designation of the intersection of West 37 Street and West 7 Court, Hialeah, Florida, as "CIRO M. SIGLER STREET", presently unnamed, is in honor and recognition of the dedication and service of Ciro M. Sigler to the City of Hialeah Parks and Recreation Department; and

**WHEREAS**, Ciro M. Sigler immigrated to the United States from Cuba at the age of 10, and resided in Hialeah until just prior to his death; and

**WHEREAS**, Ciro M. Sigler grew up playing baseball in local parks, and later worked as a baseball coach at those same parks; and

**WHEREAS**, Ciro M. Sigler worked for the City of Hialeah Parks and Recreation Department from November 1978 to January 1982; and

**WHEREAS**, Ciro M. Sigler was dedicated to his job and enjoyed working with the youth of Hialeah; and

**WHEREAS**, on March 1, 1991, Ciro M. Sigler was fatally shot by a disgruntled employee that he supervised at Alamo Rent-A-Car; and


**WHEREAS**, the Historic Preservation Board recommended approval of this resolution on July 25, 2011.

THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

**Section 1:** The intersection of West 37 Street and West\*7 Court, Hialeah, Florida, presently unnamed, is hereby co-designated as "CIRO M. SIGLER STREET",

and shall be known as such from this day forward, with the costs of signage to be paid by the City.




