The Portrait of Empowerment, Inc. (MLK Essay Competition – Student Scholarship)	\$ 150.00

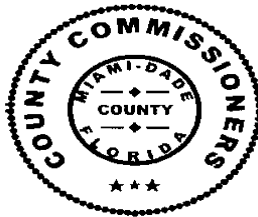
