RESOLUTION APPROVING THE CITY OF HIALEAH
CODESIGNATION OF EAST 4TH AVENUE FROM EAST
47TH STREET TO EAST 49TH STREET AS 'LORENZO
LADAGA WAY'

WHEREAS, on February 28, 2012 the City Council of the City of Hialeah adopted Resolution No. 12-24 which codesignated East 4th Avenue from East 47th Street to East 49th Street as "Lorenzo Ladaga Way," in recognition of his contributions to the City of Hialeah, a copy of which is attached and incorporated by reference; and

WHEREAS, Lorenzo Ladaga attended Hialeah Senior High School as a student, and returned several years later to serve as a baseball and football coach, leading the school teams to several state championships; and

WHEREAS, as a teacher and school principal, he was fundamental in improving students' academic performance, fostering and developing leaders and raising social consciousness; and

WHEREAS, Lorenzo Ladaga passed away in November of 2011; and

WHEREAS, East 4th Avenue from East 47th Street to East 49th Street is a city street located in the City of Hialeah; and

WHEREAS, the City of Hialeah wants the County to install signage indicating this codesignation on County street signs and traffic signal masts arms; and

WHEREAS, this codesignation is located in County Commission District 13,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Approves the City of Hialeah codesignation of East 4th Avenue from East 47th Street to East 49th Street as "Lorenzo Ladaga Way."

Section 2. Directs the Clerk of the Board to send certified copies of this Resolution to the Mayor of the City of Hialeah, the United States Postal Service, the Traffic Signals and Signs Division of the Public Works and Waste Management Department and Land Development/Right-of-Way Division of the Public Works and Waste Management Department, the Hialeah Police Department and the Hialeah Fire Department.

The Prime Sponsor of the foregoing resolution is Commissioner Esteban L. Bovo, Jr. It was offered by Commissioner **Rebeca Sosa**, who moved its adoption. The motion was seconded by Commissioner **Jose "Pepe" Diaz** and upon being put to a vote, the vote was as follows:

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA APPROVING THE CO-DESIGNATION OF A PORTION OF EAST 4 AVENUE, BETWEEN EAST 47 STREET TO EAST 49 STREET, HIALEAH, FLORIDA, AS "LORENZO LADAGA WAY", IN HONOR AND MEMORY OF THE OUTSTANDING ACHIEVEMENTS AND CONTRIBUTIONS OF LORENZO LADAGA TO THE CITY OF HIALEAH AND ITS RESIDENTS AS A COACH, MENTOR, AND EDUCATOR, WITH THE COST OF SIGNAGE TO BE PAID BY THE APPLICANT.

WHEREAS, the codesignation of that portion of East 4 Avenue, between East 47 Street and East 49 Street, Hialeah, Florida, as "Lorenzo Ladaga Way", presently unnamed, is in honor and memory of the outstanding achievements and contributions of Lorenzo Ladaga to the City of Hialeah and its residents; and

WHEREAS, Lorenzo Ladaga attended Hialeah Senior High School as a student, and returned several years later to serve as a baseball and football coach, leading the school teams to several state championships; and






