Subject: Resolution Requesting Authority to Exercise Option-to-Renew Period Under an Existing Competitively Bid Contract that Would Bring the Cumulative Contract Value to More than \$1 Million

Recommendation

It is recommended that the Board of County Commissioners (Board) delegate to the County Mayor or County Mayor's designee the authority to exercise, in their discretion, the Option-to-Renew (OTR) set forth in this item. Ordinance No. 07-139 provides for committee review exemption.

The accompanying OTR package in this item is specific to Title Company Services for the Finance and Permitting, Environment and Regulatory Affairs (PERA) Departments in the amount of \$244,000 and seeks to exercise the remaining one-year OTR, which will extend this contract from August 23, 2012 through August 22, 2013.

Scope

The impact of the item in the accompanying OTR package is countywide in nature.

Fiscal Impact/Funding Source

The funding source for the Finance Department is Tax Deed Application Fees (\$200,000) and proprietary revenues for PERA (\$44,000).

Contract amounts and department allocations represent the maximum spending authority based on estimated past usage. This action does not guarantee that the total contract amount/value will be expended by these departments. Funding will be expended only if their respective departmental budgets can support the expenditures approved in their annual budget adopted by the Board.

Track Record/Monitor

There are no known performance issues with the vendor recommended for award. The departments' contract managers are reflected in the attached OTR package.

Delegated Authority


If this item is approved, the County Mayor or County Mayor's designee will have the authority to exercise the OTR in accordance with the terms and conditions of the contract listed in the attached OTR package.

Background

This competitively bid contract was previously awarded under the delegated authority of the County Mayor or County Mayor's designee (\$1 million for competitive procurements) pursuant to Section 2-8.1(b) of the County Code and the Master Procurement Administrative Order, A.O. 3-38. Given that the cumulative value of the original contract amount and prior OTRs, as well as the OTR that is the subject of this item, exceed the aforementioned \$1 million threshold, Board approval is required to exercise this OTR.

The contract in this package was awarded prior to the effective date of Ordinance 09-52, which requires obtaining Board authorization to award contracts where the renewal options would bring the cumulative value of the contract above \$1 million.

Prior to exercising any OTR periods, market research is conducted to ensure that continuing to purchase from the awarded vendors is in the best interest of the County. Market research includes competitive factors such as pricing, quality, product features, technology, and lead time. It may also include commercial factors such as environmental issues, other governmental entity practices, industry trends, support and capabilities. The OTR for this contract is described in full detail in attached "Item 1". It will only be executed if determined to be in the best interest of the County.

Contract Title: Title Company Services

Description: It is recommended that the Board authorize the County Mayor or the County Mayor's designee to exercise the remaining Option-to-Renew (OTR) to procure title company services. The contract has one, one-year OTR remaining. Exercising the remaining OTR will bring the cumulative value of the contract to \$1,829,000.

JUSTIFICATION

The Finance Department's Tax Collector Division uses the services of a title company to provide certified ownership and encumbrance reports for tax deed applications. These reports are required under Section 197.502 of the Florida Statutes and Department of Revenue Regulation Rule 12D-13.061. The reports contain lien information on real property for which a tax deed application is filed. The Department of Permitting, Environment and Regulatory Affairs uses the services of a title company to provide ownership and encumbrance reports for properties deemed to be unsafe.

The participating departments continue to require the services of the title company under contract. The prices are competitive as compared to other State of Florida counties. The vendor is performing in a satisfactory manner. Additionally, the Finance Department expects the sale of tax deeds to increase in the near future. Therefore, it is the best interest of the County to exercise the third option-to-renew.
