## RESOLUTION NO. R-499-12

RESOLUTION APPROVING THE STATE ROAD CODESIGNATION OF NW  $59^{TH}$  STREET BETWEEN NW  $27^{TH}$  AVENUE AND NW  $25^{TH}$  AVENUE AS "MARGARET HAINES STREET"

WHEREAS, during the 2012 regular session, the Florida Legislature passed HB 7039, which, among other codesignations, codesignated NW 59<sup>th</sup> Street between NW 27<sup>th</sup> Avenue and NW 25<sup>th</sup> Avenue as "Margaret Haines Street"; and

WHEREAS, Margaret Haines was active in community outreach activities in Miami-Dade County; and

**WHEREAS**, section 334.071, Florida Statutes, provides that the installation of road codesignation signs shall be contingent on the applicable county or city commission passing a resolution in support of the particular honorary road codesignation; and

WHEREAS, NW 59<sup>th</sup> Street between NW 27<sup>th</sup> Avenue and NW 25<sup>th</sup> Avenue is a county road located in unincorporated Miami-Dade County; and

WHEREAS, this codesignation is located in County Commission District 3,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Approves the state codesignation of NW 59<sup>th</sup> Street between NW 27<sup>th</sup> Avenue and NW 25<sup>th</sup> Avenue as "Margaret Haines Street."

Section 2.
