Subject: Resolution Authorizing the Execution of an Interlocal Agreement between the City of Doral and Miami-Dade County for Sponsorship of an Adopt-a-Tree Event in the City of Doral

Recommendation

It is recommended that the Board of County Commissioners approve the attached resolution authorizing the execution of an Interlocal Agreement (Attachment A) between the City of Doral ("Doral") and Miami-Dade County ("the County") to provide funding and sponsorship for an Adopt-A-Tree event to be held in the City of Doral in September 2012.

Scope

The City of Doral is in Commissioner Diaz's District 12.

Fiscal Impact/Funding Source

The budget for the Doral Adopt-A-Tree event is approximately \$90,000. Doral will contribute up to \$40,000 for the purchase of trees for the event. The Miami-Dade County Department of Regulatory and Economic Resources will pay all other related costs. Without the proposed Interlocal Agreement, the County would be responsible for all costs of this event. The County funds are under Index Code PE387167, Subject 49620.


Track Record/Monitor

The Assistant Director of the Department of Regulatory and Economic Resources will monitor this agreement.

Background

Since 2001, the Miami-Dade County Adopt-A-Tree Program has given away over 163,900 trees to residents of Miami-Dade County at events held throughout the County. Following a 2009 Adopt-a-Tree event in Doral, the Doral City Council entered into Interlocal Agreements to sponsor additional events in 2010 and in 2011. The Adopt-A-Tree event held in Doral on September 24, 2011 distributed over 2,200 free trees. Due to the success of that event, the Doral City Council adopted Resolution No. 12-42 (Attachment B) on April 11, 2012, approving the Interlocal Agreement for Doral to provide up to \$40,000 to the County for the purchase of trees for an Adopt-A-Tree event to be held in Doral in September 2012. Although the City of Doral will provide funding, this Adopt-a-Tree event, like all Adopt-a-Tree events, will be open to all owners of single-family homes and duplexes in Miami-Dade County, who can receive two (2) free trees per year.

The attached resolution authorizes the execution of the Interlocal Agreement and is recommended for approval.

RESOLUTION AUTHORIZING THE EXECUTION OF AN INTERLOCAL AGREEMENT BETWEEN THE CITY OF DORAL AND MIAMI-DADE COUNTY FOR SPONSORSHIP OF AN ADOPT-A-TREE EVENT IN THE CITY OF DORAL; AND AUTHORIZING THE MAYOR OR MAYOR'S DESIGNEE TO EXERCISE ALL PROVISIONS THEREIN

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board hereby authorizes the Mayor or Mayor's designee to execute an Interlocal Agreement between the City of Doral and Miami-Dade County for the City of Doral to provide up to \$40,000 toward the purchase of trees for an Adopt-A-Tree event in the City of Doral to be held in September 2012, in substantially the form attached hereto and made part hereof; authorizes the Mayor or Mayor's designee to execute any necessary amendments to this agreement for time extension and to accept additional funds that may become available for this agreement; and authorizes the Mayor or Mayor's designee to exercise the provisions contained therein.



ATTACHMENT A

INTERLOCAL AGREEMENT

Between the City of Doral and Miami-Dade County for Sponsorship of the Adopt-A-Tree Event in the City of Doral

This Interlocal Agreement by and between the City of Doral, Florida ("the City") and Miami-Dade County, Florida ("the County") is entered into to provide sponsorship of an Adopt-A-Tree event to be held within the City of Doral in September 2012 ("the Event"). For purposes of this Interlocal Agreement ("this Agreement"), the Miami-Dade County Department of Permitting, Environment and Regulatory Affairs shall administer this Interlocal Agreement for and on behalf of Miami-Dade County.

1. The City agrees to contribute up to and including \$40,000 to the County for up to and including 2,750 trees to be given to the public during the Event. Prior to the Event, County staff shall coordinate with the City on the number and species of trees to stay within the tree budget provided by the City as well as to coordinate the date, time, location, logistics and related specifics.
2. All other costs for the event shall be paid by the County or other sponsors or both, through the County.
3. This Agreement shall commence upon final execution by both parties and shall terminate on September 30, 2012, unless otherwise amended as provided for herein.
4. The City shall cooperate with the County in the selection of tree species within the parameters of the County's Adopt-A-Tree Program. Trees selected for the event shall be no greater than 3" trunk diameter/caliper in size. All trees shall be grade Florida #1 or better, in accordance with nursery industry guidelines provided in "Grades and Standards for Nursery Plants."
5. The City shall cooperate with the County on selection of the date, location and any other decisions necessary for the Event. The County agrees to conduct all required work to obtain the trees for the Event. The County shall deliver the trees to the Event location one day prior to the Event unless other arrangements are mutually agreed upon by the parties.
6. The maximum amount the City shall reimburse the County for trees purchased for the Event and for the life of this Agreement is \$40,000.00.
7. Deliverables and Payments.
 - a. The City agrees to reimburse the County for costs of trees as set forth in this Agreement. The County shall provide to the City an invoice for the actual cost of all trees purchased for the Adopt-A-Tree event in the City.
 - b. Payment by the City of the invoiced amount to the County shall be made not later than thirty (30) days after receipt of the invoice by the City.
8. This Agreement may be modified by amendment through mutual written agreement of both parties. All amendments to this Agreement shall be in writing and signed by both parties, and shall become effective as on the date of the final signatory unless otherwise noted therein.
9. This Agreement becomes effective upon final execution by the parties:

RESOLUTION NO. 12-42

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN INTERLOCAL AGREEMENT WITH MIAMI-DADE COUNTY PERMITTING ENVIRONMENT & REGULATORY AFFAIRS (PERA) FOR THE 2012 ADOPT-A-TREE PROGRAM; AUTHORIZING THE CITY MANAGER TO EXPEND AN AMOUNT NOT TO EXCEED \$40,000.00 FROM THE DORAL ENVIRONMENTAL ADVISORY BOARD BUDGET FOR THE PURCHASE OF TREES FOR THE SEPTEMBER 2012 ADOPT-A-TREE EVENT AT J.C. BERMUDEZ PARK IN THE CITY OF DORAL; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the 2011 Adopt-a-Tree event was a great success whereby the City provided approximately 2,000 trees free of charge to the community; and

WHEREAS, this event was hosted and sponsored by the City of Doral and co-sponsored by the Miami-Dade County Permitting Environment & Regulatory Affairs (PERA); and

WHEREAS, Staff and the Doral Environmental Advisory Board (DEAB) respectfully request that the City Council authorize the City Manager to enter into an Interlocal Agreement with PERA for the 2012 City of Doral Adopt-A-Tree event; and

WHEREAS, Staff and the DEAB further request that the City Council authorize the City Manager to expend an amount not to exceed \$40,000.00 from the DEAB budget for the purchase of trees for the September 2012 Adopt-a-Tree event at J.C. Bermudez Park in the City of Doral.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. The City Council of the City of Doral hereby authorizes the City Manager to enter into an Interlocal Agreement with PERA for the 2012 City of Doral Adopt-A-Tree event.

Section 2. The City Council further authorizes the City Manager to expend an amount not to exceed \$40,000.00 from the DEAB budget for the purchase of trees for the September 2012 Adopt-a-Tree event at J.C. Bermudez Park in the City of Doral.

Section 3. This Resolution shall become effective immediately upon adoption.
