Subject: Recommendation for Approval to Establish a Pre-Qualification Pool: Law Enforcement Equipment and Supplies
Resolution No. R-544-12

Recommendation

It is recommended that the Board of County Commissioners (Board) authorize the attached resolution approving establishment of a pre-qualification pool for purchase of law enforcement equipment and supplies for various County departments. The equipment and supplies covered under this contract include police guns, rifles, ammunition, tear gas, grenades, leg irons, handcuffs, waist chains, batons, protection equipment and other related equipment and supplies for Miami-Dade Police (MDPD), Corrections, Aviation, and Park, Recreation and Open Spaces Departments. MDPD is the primary user of this contract.

An Invitation to Bid was issued under full and open competition on February 29, 2012. The proposed allocation for this pool award is \$6,700,000 for five years, and consolidates three contracts that are currently used to purchase these items. The requested allocation is lower than the existing contracts due to decreased anticipated usage by the user departments. Additionally, it is expected that this pool of pre-qualified bidders will allow the County to secure the most competitive pricing for each purchase.

The recommended pre-qualification pool includes five local vendors and ten non-local vendors. In addition, there is one local firm that has applied to the pool and is pending compliance with the County's requirements in order to be added to the pool. Staff will continue outreach efforts to maximize local vendor participation.

Contract Number and Title

1088-0/17 - Law Enforcement Equipment and Supplies, Pre-qualification of Bidders

Scope

The impact of this item is countywide in nature.

Track Record/Monitor

The Aviation, Corrections and Rehabilitation, Police, and Park, Recreation and Open Spaces are the user departments and the Internal Services Department monitors the contract. Constance Thame of the Internal Services Department is the Procurement Contracting Officer.

Fiscal Impact/Funding Source

The fiscal impact for this pre-qualification pool is up to \$6,700,000 for the five-year term distributed by funding source as follows:

Due Diligence


Due diligence was conducted in accordance with the Internal Services Department's Procurement Guidelines to determine Contractor responsibility, including verifying corporate status and that there are no performance or compliance issues. The lists that were referenced include: convicted vendors, debarred vendors, delinquent contractors, suspended vendors, and federal excluded parties. There were no adverse findings relating to Contractor responsibility. This information is being provided pursuant to Resolution R-187-12.

Delegated Authority

Upon approval of this item, a pool of pre-qualified bidders will be established to participate in spot market competitions. The County Mayor or designee will have the authority to solicit pricing and award contracts up to an aggregate contract amount of the allocation authorized by the Board. Additionally, the County Mayor or designee may add qualified vendors to the pool at any time during the contract term, subject to bi-annual ratification by the Board. The County Mayor or designee will also have the authority to exercise, at their discretion, contract modifications and subsequent extensions in accordance with the terms and conditions of the pool contract.

Applicable Ordinances and Contract Measures

The Small Business Enterprise (SBE) Bid Preference will be applied in accordance with the Ordinance at the time of spot market competitions. The services being provided are not covered under the Living Wage Ordinance. The Local Preference will be applied in accordance with the Ordinance at the time of spot market competitions. The 2% User Access Program provision will apply, and will be collected on all purchases.

RESOLUTION NO. R-544-12

RESOLUTION AUTHORIZING THE ESTABLISHMENT OF A PRE-QUALIFICATION POOL FOR CONTRACT NO. 1088-0/17, LAW ENFORCEMENT EQUIPMENT AND SUPPLIES, PRE-QUALIFICATION OF BIDDERS, IN AN AMOUNT UP TO \$6,700,000 FOR THE FIVE YEAR TERM, AND AUTHORIZING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO CONDUCT SPOT BIDS AND AWARD SUBSEQUENT CONTRACTS, ADD VENDORS, CONDUCT MODIFICATIONS, AND EXERCISE, IN THEIR DISCRETION, ANY CANCELLATION PROVISIONS, AND TO EXERCISE ALL OTHER RIGHTS CONTAINED THEREIN

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board hereby directs the County Mayor or County Mayor's designee to authorize the establishment of a pre-qualification pool for Contract No. 1088-0/17, Law Enforcement Equipment and Supplies, Pre-Qualification of Bidders, in an amount up to \$6,700,000 for the five year term, and authorizes the County Mayor or County Mayor's designee to conduct spot bids and award subsequent contracts, add vendors, subject to ratification by the Board on a bi-annual basis, conduct modifications, and exercise, in their discretion, any cancellation provisions in accordance with the terms and conditions of the contract on behalf of Miami-Dade County, and all other rights contained therein.
