RESOLUTION NO. R-518-12

RESOLUTION APPROVING THE STATE ROAD  
CODESIGNATION OF S.W. 57 AVENUE/RED ROAD  
BETWEEN S.W. 78 STREET AND S.W. 88 STREET AS  
“AMADEO LOPEZ-CASTRO, JR. ROAD”

**WHEREAS**, during the 2012 regular session, the Florida Legislature passed HB 7039, which codesignated S.W. 57 Avenue/Red Road between S.W. 78 Street and S.W. 88 Street as “Amadeo Lopez-Castro, Jr. Road”; and

**WHEREAS**, Amadeo Lopez-Castro, Jr. was born on May 25, 1936 to Amadeo Lopez-Castro and Guillermina Corali Rodriguez San Pedro; and

**WHEREAS**, Lopez-Castro was an engineer and banker who served as chairman of the Public Health Trust; and

**WHEREAS**, he died in Strasbourg, France on October 29, 2010; and

**WHEREAS**, section 334.071, Florida Statutes, provides that the installation of road codesignation signs shall be contingent on the applicable county or city commission passing a resolution in support of the particular honorary road codesignation; and

**WHEREAS**, S.W. 57 Avenue/Red Road between S.W. 78 Street and S.W. 88 Street as “Amadeo Lopez-Castro, Jr. Road” is a state road that forms the boundary between the City of South Miami to the west and unincorporated Miami-Dade County to the east; and

**WHEREAS**, this codesignation is located in County Commission District 7,

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA,** that this Board:

**Section 1.** Approves the state codesignation of S.W. 57 Avenue/Red Road between S.W. 78 Street and S.W. 88 Street as “Amadeo Lopez-Castro, Jr. Road”.

**Section 2.** Directs the Clerk of the Board to send certified copies of this Resolution to the City Manager of the City of South Miami, the United States Postal Service, the Traffic Signals and Signs Division of the Public Works and Waste Management Department, the Land Development/Right-of-Way Division of the Public Works and Waste Management Department, the City of South Miami Police Department, and the Miami-Dade Fire Rescue Department.

The Prime Sponsor of the foregoing resolution is Commissioner Xavier L. Suarez. It was offered by Commissioner **Sally A. Heyman** , who moved its adoption. The motion was seconded by Commissioner **Lynda Bell** and upon being put to a vote, the vote was as follows:
