RESOLUTION URGING THE FLORIDA LEGISLATURE AND GOVERNOR RICK SCOTT TO CONTINUE FUNDING THE CENTRAL ACCESS CUSTOMER SERVICE CENTER OF THE FLORIDA DEPARTMENT OF CHILDREN AND FAMILIES LOCATED AT 1490 NORTHWEST 27 AVENUE, MIAMI, FLORIDA

**WHEREAS**, the Central Access Customer Service Center ("Central Service Center") of the Florida Department of Children and Families faces the threat of having all of its funding eliminated; and

**WHEREAS**, the Central Service Center is located at 1490 Northwest 27<sup>th</sup> Avenue, and provides essential assistance to the residents of the City of Miami and surrounding areas; and

**WHEREAS**, the Central Service Center provides enhanced access to services such as food assistance for low-income individuals and families, temporary cash assistance for families with minor, dependent children and pregnant women in their last trimester, and Medicaid for low-income individuals; and

**WHEREAS**, the Central Service Center is able to provide enhanced access to these services through a combination of Department staff and providers; and

**WHEREAS**, it is critically important to the families in need who live near the Central Service Center that it remain open to provide these important services; and

**WHEREAS**, the Cities of Hialeah and Miami have both passed resolutions supporting the Central Service Center remaining open, copies of which are attached and incorporated by reference; and

**WHEREAS**, this Board would like to join these cities in urging the Florida Legislature and Governor Rick Scott to continue funding the Central Service Center,

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA**, that this Board:

**Section 1.** Urges the Florida Legislature and Governor Rick Scott to continue funding the Central Access Customer Service Center of the Florida Department of Children and Families located at 1490 Northwest 27<sup>th</sup> Avenue.

**Section 2.** Directs the Clerk of this Board to send a certified copy of this resolution to the Governor, Senate President, House Speaker, and the Chair and Members of the Miami-Dade State Legislative Delegation and the Secretary of the Florida Department of Children and Families.

**Section 3.** This Board directs the County's state lobbyists to advocate for the passage of the legislation and action set forth in section 1 above, and authorizes and directs the Office of Intergovernmental Affairs to amend the 2012 State Legislative Package to include this and to include this item in the 2013 State Legislative Package when it is presented to the Board.

The Prime Sponsor of the foregoing resolution is Commissioner Bruno A. Barreiro. It was offered by Commissioner **Sally A. Heyman**, who moved its adoption. The motion was seconded by Commissioner **Lynda Bell** and upon being put to a vote, the vote was as follows:

Section 2. The Miami City Commission urges Governor Rick Scott and the State of Florida to continue funding the Central Service Center located at 1490 Northwest 27th Avenue, Miami, Florida.

Section 3. The City Clerk is directed to transmit a copy of this Resolution to Governor Rick Scott, Secretary David Wilkins and other appropriate state officials.

Section 4. This Resolution shall become effective immediately upon its adoption and signature of the Mayor.{1}

**Section 1.** The foregoing facts and recitations contained in the preamble of this resolution are hereby adopted and incorporated by reference as if fully set forth herein.




