RESOLUTION APPROVING THE CITY OF HIALEAH
CODESIGNATION OF EAST 5 STREET BETWEEN EAST 4
AVENUE AND EAST 6 AVENUE AS "ANGEL HERNANDEZ
WAY"

WHEREAS, on May 9, 2012, the City Council of the City of Hialeah adopted Resolution No. 12-55 which codesignated East 5 Street between East 4 Avenue and East 6 Avenue as "Angel Hernandez Way", in recognition of his outstanding service and contributions to the City of Hialeah and its residents, a copy of which is attached and incorporated by reference; and

WHEREAS, Angel Hernandez was the founder of the Hialeah Khoury League 34 years ago; and

WHEREAS, Hernandez was a leader in sports and a mentor to hundreds of youths who have become highly recognized baseball players and officials throughout the world; and

WHEREAS, Hernandez participated in educating over 60,000 young adults in the Hialeah Khoury League, demonstrating a love for the sport and respect for the game; and

WHEREAS, Hernandez lived in the City of Hialeah for over 48 years, and his family still resides in the City; and

WHEREAS, Angel Hernandez died earlier this year, but his commitment and dedication to the youth of Hialeah will always be remembered; and

WHEREAS, East 5 Street between East 4 Avenue and East 6 Avenue is a city street located in the City of Hialeah; and

WHEREAS, the City of Hialeah wants the County to install signage indicating this codesignation on County street signs and traffic signal masts arms; and

WHEREAS, this codesignation is located in County Commission District 6,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Approves the City of Hialeah codesignation of East 5 Street between East 4 Avenue and East 6 Avenue as "Angel Hernandez Way".

Section 2. Directs the Clerk of the Board to send certified copies of this Resolution to the Mayor of the City of Hialeah, the United States Postal Service, the Traffic Signals and Signs Division of the Public Works and Waste Management Department, the Zoning and Platting Division of the Department of Regulatory and Economic Resources, the City of Hialeah Police Department, and the City of Hialeah Fire Department.

The Prime Sponsor of the foregoing resolution is Commissioner Rebeca Sosa. It was offered by Commissioner **José "Pepe" Diaz**, who moved its adoption. The motion was seconded by Commissioner **Audrey M. Edmonson** and upon being put to a vote, the vote was as follows:

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA APPROVING THE CO-DESIGNATION OF A PORTION OF EAST 5 STREET, BETWEEN EAST 4 AVENUE AND EAST 6 AVENUE, HIALEAH, FLORIDA, AS "ANGEL HERNANDEZ WAY", IN HONOR AND RECOGNITION OF HIS OUTSTANDING SERVICE AND CONTRIBUTIONS TO THE CITY OF HIALEAH AND ITS RESIDENTS, WITH THE COST OF SIGNAGE TO BE PAID BY THE CITY.

WHEREAS, Angel Hernandez lived in the City of Hialeah for over 48 years, and his family still resides in the City; and

WHEREAS, Angel Hernandez died in 2012, but his commitment and dedication to the youth of Hialeah will always be remembered; and

WHEREAS, the Historic Preservation Board recommended approval of this resolution on May 1, 2012.


