



**Subject:** Executive Summary for the Contract Award Recommendation for Design-Build Services  
for the Lehman Center Test Track / Lehman Yard Rehabilitation - Expansion Phase 1

It is recommended that the Board of County Commissioners (Board) approve a \$25,147,257 award to Munilla Construction Management, LLC (MCM) for Design-Build Services for the Lehman Center Test Track / Lehman Yard Rehabilitation - Expansion Phase 1, Project No: DB10-MDT-01 PTP, Contract No: CIP028-CT1-TR09.

#### **Background on Solicitation Process**

Due to budget constraints, the proposed test track and additional storage tracks were not included in the Lehman Center facilities contract which was awarded prior to 1983. In 2002, the test track and storage tracks were included in Miami-Dade Transit's (MDT's) Capital Improvement Plan approved by the Board for financing by the People's Transportation Plan Bond Program.

The Request to Advertise (RTA) for this project was approved by the Assistant County Manager on May 29, 2010 and was subsequently certified by the Clerk of the Board on June 2, 2010. The Notice to Proceed with Design-Build Services was issued on June 11, 2010 for a two-step selection process. The first step was to evaluate four proposals received on October 25, 2010 based on the prime firm's qualifications and experience, technical qualifications and certifications of the prime's design team members, compliance with licensing agreements; ability to meet insurance and bond requirements; and the firm's commitment to comply with the County's programs. One of the proposers, Herzog Contracting Corporation, was deemed non-compliant and the Competitive Selection Committee evaluated the remaining three proposals, which were ranked in the following order: 1) Odebrecht Construction, Inc (Odebrecht), 2) Kiewitt Infrastructure South Company (Kiewitt), and 3) MCM.

The second step of the process included scoring the technical proposals and oral presentations for project design and construction approach, and the ability to provide the services within budget and on schedule. Odebrecht advised the County that it would not submit a technical and price proposal and the remaining two firms submitted their proposals on December 6, 2010. Kiewitt was ranked first and initial negotiations were held with the firm, during which Kiewitt was asked to reduce its original price proposal to an amount similar to the engineer's cost estimate. Kiewitt requested a site visit, and as a result of the visit determined that a price reduction was not feasible. After further opportunities to reduce their price proposal, negotiations were discontinued with Kiewitt and negotiations began with MCM, the second ranked firm. MCM agreed to reduce their based contract amount by \$993,560 but it was still 18.24 percent higher than the engineer's cost estimate. It was determined by the Selection Committee that MCM's price proposal was fair and reasonable given the amount of time that had elapsed by that point since the 2009 cost estimate and the limited contractor participation.

#### **Background on Lehman Center Test Track/Lehman Yard Rehabilitation Project**

Currently, new vehicle testing and acceptance cannot take place during normal service hours in an effort to avoid a train accident. There are only three productive non-revenue service hours currently available per day for testing of repaired vehicles, which is inadequate to support ongoing maintenance and future testing and acceptance programs. The Lehman Yard expansion to be performed under this award includes design.

and construction of test track, siding track, inspection building, new storage tracks, maintenance tracks, a train control and communication house. Expansion of the yard will improve MDT's vehicle performance testing and maintenance, in accordance with peak vehicle requirements, by eliminating the need to wait for specific times to move vehicles for repairs and testing without impacting the movement of other vehicles. This will result in improved rail operations and decreased MDT's operating expenses.



## Recommendation

It is recommended that the Board of County Commissioners (Board) approve an award for Design-Build Services for the Lehman Center Test Track / Lehman Yard Rehabilitation - Expansion Phase 1, Project No: DB10-MDT-01 PTP, Contract No: CIP028-CT1-TR09 between Munilla Construction Management, LLC, hereinafter referred to as MCM, and Miami-Dade County, in the amount of \$25,147,257.00. This award recommendation has been prepared by Miami-Dade Transit (MDT) and recommended for approval pursuant to Section 2-8.2.7 of the Code of Miami Dade County.

This contract award recommendation is placed for Committee review pursuant to Miami-Dade County Code Section 29-124(f). This contract award recommendation may only be considered by the Board if the Citizens' Independent Transportation Trust (CITT) has forwarded a recommendation to the Board prior to the date scheduled for Board consideration or forty-five (45) days have elapsed since the filing with the Clerk of the Board of this contract award recommendation. If the CITT has not forwarded a recommendation and forty-five (45) days have not elapsed since the filing of this award recommendation, I will request a withdrawal of this item.

**Delegation of Authority** - The authority of the County Mayor or County Mayor's designee to execute and implement this contract is consistent with those authorities granted under the Code of Miami-Dade County.

## Scope

**PROJECT NAME:** Design-Build Services for the Lehman Center Test Track / Lehman Yard Rehabilitation - Expansion Phase 1

**PROJECT NO:** DB10-MDT-01 PTP

**CONTRACT NO:** CIP028-CT1-TR09

**PROJECT DESCRIPTION:** Design and construction services are required at the Lehman Center in order to build a test track, siding track, storage tracks, inspection building, train control and communication house.

The Design-Build team will manage the final design, permitting, construction, equipment furnish and installation, testing, operating system implementation, system integration and acceptance of the following project components: test track, siding track, inspection building, five new storage tracks, two maintenance of way tracks, a train control and communication house. This work includes implementation of a train control system, Closed Circuit Television CCTV, telephone systems and traction power connection along with the addition of track switches remotely controlled by the existing control panel at the Lehman Yard Tower.

Implementation of the test track will significantly improve rail operations, decrease MDT's operating expenses, and enhance vehicle testing and maintenance performance, in accordance with Peak Vehicle Requirements. The Lehman Yard expansion will provide 24/7 testing capability for the existing fleet, increase efficiency, and will support the transition from decommissioning the old fleet to acceptance of the new fleet.

In 2002, the test track and storage tracks were included in MDT's Capital Improvement Plan approved by the Board for financing by the People's Transportation Plan Bond Program.

 According to the Sustainability, Planning & Economic Development Department's Small Business Development (SPEED / SBD) division's violations report as of February 17, 2012, there have been no violations reported for Munilla Construction Management, LLC. (See attached report)

**EXPLANATION:**  
 The Request to Advertise (RTA) for this project was approved by the Assistant County Manager on May 29, 2010 and was subsequently certified by the Clerk of the Board on June 2, 2010. The Notice to Proceed for Design-Build Services was issued on June 11, 2010. A two-step selection process was utilized for this solicitation.

Step 1 included the evaluation of the prime firm's qualifications and experience; technical qualifications and certifications of the prime's design team members; compliance with all licensing requirements; commitment to meet the goals of both the Community Business Enterprise and Community Small Business Enterprise programs; and ability to meet insurance and bond requirements.

For Step 1, a total of four proposals were received on October 25, 2010. Herzog Contracting Corporation was non-compliant with the technical certification requirements and therefore eliminated from further evaluation. On November 17, 2010, the Competitive Selection Committee evaluated the three remaining firms and ranked them as follows: (1) Odebrecht Construction, Inc.; (2) Kiewitt Infrastructure South Company (Kiewitt); and (3) Munilla Construction Management, LLC, (MCM).

On December 6, 2010, Odebrecht Construction, Inc. forwarded correspondence advising the Internal Services Department (ISD) that they would not be submitting a technical and price proposal for the project and was therefore eliminated from further consideration.

Step 2 included scoring the technical proposals and oral presentations in accordance with the following criteria: project design approach, project construction approach, and ability to provide required services on schedule and within budget.

Two firms submitted proposals to ISD on December 6, 2010, and oral presentations took place on December 21, 2010.

Pursuant to the negotiation authorization approved on July 26, 2011, the following firms were selected in order of ranking: (1) Kiewitt and (2) MCM.

An initial negotiations meeting was held with Kiewitt on August 9, 2011, during which Kiewitt was requested to reduce its original price proposal to an amount closer to the engineer's cost estimate. Kiewitt requested a site visit to evaluate the feasibility of a price reduction. As a result, a site visit was held on August 23, 2011. On September 9, 2011, Kiewitt sent the Committee formal notification that a price reduction was not feasible based on its analysis of site conditions and other considerations. As a result, the Committee held a procedural meeting on September 20, 2011 to evaluate whether to pursue further negotiations with Kiewitt. The Committee coordinator provided advance notice to Kiewitt about the meeting and advised its attendance was optional. The Committee gave Kiewitt a final opportunity to reduce its price during the second negotiations meeting held on September 29, 2011, but negotiations were discontinued once Kiewitt advised that no reduction from its original price of \$26,464,069 would be forthcoming.

Pursuant to Florida Statutes 287.055, Miami-Dade County Code 2-10.4 and Administration Order 3-39, authorization to terminate negotiations with Kiewitt and approval to begin negotiations with the second highest ranked design-builder, MCM, was approved on October 12, 2011.

The Committee began negotiations with MCM, on November 1, 2011. A second negotiations meeting was held on December 1, 2011, and a site visit was held on December 15, 2011 at MCM's request. A third negotiations meeting was held on January 10, 2012 and negotiations were concluded during the final meeting on February 3, 2012. The Committee successfully negotiated a new base contract amount of \$23,295,000.00, representing a net discount of \$993,560.00 from MCM's original base price of \$24,288,560.00. Once negotiations with MCM were finalized, MCM's price was 18.24% higher than the engineer's cost estimate. However, the Committee found it reasonable for a

design builder to perform the original scope of work at a higher price due to escalation of electrical, mechanical, train control, and communication system equipment prices since the 2009 cost estimate and necessary to maintain product integrity. Limited contractor participation and relatively small contract size for this type of work also contributed to the higher cost proposal. As such, the Committee determined MCM's negotiated price was fair and reasonable, and in the best interests of the County.


The Lehman Yard expansion includes design and construction of test track, siding track, inspection building, new storage tracks, maintenance tracks, a train control and communication house. Expansion will improve MDT's vehicle performance testing and maintenance, in accordance with peak vehicle requirements. MDT's rail operations and maintenance capability will significantly improve by eliminating the need to wait for specific times to move vehicles for repairs and testing without impacting the movement of other vehicles.

New vehicle testing and acceptance cannot take place during normal service hours to avoid the occurrence of a train accident. There are only three productive non-revenue service hours currently available per day for testing of repaired vehicles. This is inadequate to support ongoing maintenance and any future testing and acceptance programs.

The project will support delivery, qualification, acceptance, and safety certification testing of new Metrorail vehicles presently under procurement. The vehicles will be safety certified on the new test track and mainline before being placed into revenue service. The test track will improve vehicle maintenance and operations, allowing

MDT to maintain its testing schedule and acceptance of six new vehicles per month.

The Test Track will provide 24/7 testing capability for the existing fleet and acceptance of new fleet, enabling a quick turnaround for repair and return of vehicles to service. The track will relieve the existing maintenance shop of overcrowding, and eliminate the need for using the mainline tracks to test vehicle performance after repairs and overhauls are completed.

In accordance with the letter opinion issued by Robert Meyers, Executive Director, Miami-Dade Commission on Ethics and Public Trust dated August 31, 2011 ("Ethics Opinion"), I hereby delegate to you all delegable authority relating to the administration of solicitation DB10-MDT-01 PTP Design Build Services for the Lehman Center Test Tract/Lehman Yard Rehabilitation Expansion Phase I including, but not limited to, the authority to recommend to the Board of County Commissioners the award of the solicitation to a contractor. As I will not be sponsoring any award recommendation of this solicitation under the authority of the County Mayor you should request that any recommended disposition of this solicitation which you deem to be in the best interest of Miami-Dade County be sponsored by a County Commissioner in accordance with the Commission's Rules of Procedure. I further delegate to you all delegable authority to administer any contract awarded as a result of DB10-MDT-01 PTP Design Build Services for the Lehman Center Test Tract/Lehman Yard Rehabilitation Expansion Phase I. You should exercise this authority and utilize your own judgment and should take all actions which are in the best interest of Miami-Dade County and consistent with the County Code, regulations, rules and the solicitation documents. 

Pursuant to the October 3, 2011 memorandum from Mayor Carlos A. Gimenez, (see attachment A), regarding an Ethics Opinion rendered, please be advised that this memorandum involves MCM (Munilla Construction Management, LLC).

On July 29th, 2011, the Office of Capital Improvements (OCI) received authorization to enter into negotiations, (see attachment B), with Design-Builder Kiewit Infrastructure South Co. (Kiewit), for design-build services for the Lehman Center Test Track / Lehman Yard Rehabilitation Expansion Phase I.


The appointed Negotiation Committee (Committee) met on three occasions; two of the three meetings were with Kiewit. In addition to the negotiation meetings, a site visit (August 23, 2011) was requested by Kiewit. These publicly noticed meetings occurred between August 09, 2011 and September 29, 2011. Throughout the various sessions, in which Kiewit was in attendance, the Committee attempted to negotiate a reduction of Kiewit's original price proposal of \$26,464,069. Kiewit's price proposal is \$5,169,271 in excess of the \$21,294,798 estimated total budget for this project. On September 09, 2011 OCI received a letter from Kiewit (see attachment C) indicating that based on their August 23<sup>rd</sup> site visit, they would not be able to reduce their price.

During negotiation meeting no. 3, Kiewit indicated to the Committee that they would not be able to further reduce their price. As such, the Committee unanimously agreed to recommend to the County Mayor to terminate negotiations with Kiewit.

Pursuant to Florida Statutes 287.055, Miami Dade Code Section 2-10.4 and Administrative Order 3-39, upon your approval of the Committee's recommendation to terminate negotiations with Kiewit, the Committee will proceed to enter into negotiations with the second ranked design builder MCM.




