

RESOLUTION NO. R-936-12

RESOLUTION DIRECTING THE COUNTY MAYOR OR MAYOR'S DESIGNEE TO COORDINATE WITH THE MIAMI-DADE EXPRESSWAY AUTHORITY (MDX) AND THE FLORIDA DEPARTMENT OF TRANSPORTATION (FDOT) TO PRIORITIZE THE DEVELOPMENT AND IMPLEMENTATION OF BUS RAPID TRANSIT ALONG STATE ROAD 836 AND FURTHER DIRECTING THE COUNTY MAYOR OR MAYOR'S DESIGNEE TO SUBMIT A PROGRESS REPORT TO THE COUNTY COMMISSION WITHIN 60 DAYS

WHEREAS, State Road 836 is a major east-west thoroughfare through Miami-Dade County; and

WHEREAS, State Road 836 is a highly congested roadway; and

WHEREAS, Bus Rapid Transit along State Road 836 would reduce congestion and provide safe and efficient transportation options for residents and visitors to Miami-Dade County; and

WHEREAS, Miami-Dade Transit has implemented successful Bus Rapid Transit lines along I-95 and the South-Dade Busway; and

WHEREAS, State Road 836 is operated and maintained by the Miami-Dade Expressway Authority (MDX); and

WHEREAS, the successful I-95 and South-Dade Busway Bus Rapid Transit lines were the result of close coordination between Miami-Dade County and the Florida Department of Transportation (FDOT); and

WHEREAS, a coordinated effort between Miami-Dade County, MDX, and FDOT is likely to result in the successful development and implementation of a Bus Rapid Transit line along State Road 836,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board directs the County Mayor or Mayor's designee to coordinate with the Miami-Dade Expressway Authority and the Florida Department of Transportation to prioritize the development and implementation of Bus Rapid Transit along State Road 836 and further directs the County Mayor or Mayor's designee to submit a progress report within 60 days to the County Commission.

The Prime Sponsor of the foregoing resolution is Commissioner Jose "Pepe" Diaz.

It was offered by Commissioner **Rebeca Sosa**, who moved its adoption. The motion was seconded by Commissioner **Lynda Bell** and upon being put to a vote, the vote was as follows:
