Subject: Resolution Waiving the Requirement for an Annual Income Statement for Additional
Homestead Exemption for Certain Disabled Persons

RECOMMENDATION

It is recommended that the Board of County Commissioners (Board) waive the requirement for annual income statements for additional Homestead Exemption for certain disabled persons after the initial application is made and granted.

SCOPE

The annual income statements waiver for additional Homestead Exemption will benefit eligible property owners countywide and shall apply to the 2013 assessment roll and the assessment roll of each year thereafter until rescinded by the Board.

FISCAL IMPACT/FUNDING SOURCE

There is no fiscal impact.

TRACK RECORD/MONITOR

Section 196.101 of the Florida Statutes requires an annual application, annual income statements and certain additional proof of income including tax returns (income statements) to be submitted to the Property Appraiser's Office (PA) to maintain eligibility for the Homestead Exemption for Totally and Permanently Disabled Persons. Through Resolution R-1448-89, this Board has previously waived the requirement for annual applications for the Homestead Exemption for certain disabled persons. Waiving the requirement for annual income statements would make the exemption renew automatically similarly to other exemptions, which do not currently require income statements. Section 196.011 of the Florida Statutes includes language that affords reasonable course of action for the PA to recover the additional exemption should this exemption be improperly claimed under automatic renewal.

BACKGROUND

Pursuant to Section 196.011(9)(a) of the Florida Statutes, a county may, upon the request of the Property Appraiser and by a majority vote of its governing body, waive the requirement for annual income statements as provided in Section 196.101 of the Florida Statutes.

Therefore, it is recommended that the Board adopt the attached resolution waiving the requirement for annual income statements for Homestead Exemption for Totally and Permanently Disabled Persons after the initial application is made and granted.



RESOLUTION NO. R-991-12

RESOLUTION WAIVING THE REQUIREMENT FOR ANNUAL INCOME STATEMENT FOR ADDITIONAL HOMESTEAD EXEMPTIONS FOR CERTAIN DISABLED PERSONS PURSUANT TO FLORIDA STATUTE 196.101 IF THERE HAS BEEN NO CHANGE IN ELIGIBILITY FOR EXEMPTION

WHEREAS, pursuant to section 196.101 of the Florida Statutes, the homestead of certain totally and permanently disabled persons who meet a certain maximum household income threshold is exempt from taxation; and

WHEREAS, section 196.101 requires an annual application and annual income statements and certain additional proof of income including tax returns (“Income Statement”) to be submitted to the property appraiser to maintain eligibility for these exemptions; and

WHEREAS, pursuant to section 196.011(9)(a) of the Florida Statutes, a county may, upon the request of the property appraiser and by a majority vote of its governing body, waive the requirement that an annual application or statement be made for the renewal of the exemptions provided in section 196.101; and

WHEREAS, through Resolution R-1448-89, this Board has previously waived the requirement for annual applications for the exemption provided in section 196.101, as permitted by section 196.011(9)(a); and

WHEREAS, the Miami-Dade County Office of the Property Appraiser (“Property Appraiser”) has requested this Board to also waive the requirement for an annual Income Statement as provided in section 196.101 of the Florida Statutes; and

WHEREAS, waiving the requirement for an annual Income Statement for entitlement to these exemptions would make these exemptions renew automatically similarly to other exemptions which do not currently require renewal applications or statements; and

WHEREAS, this Board is required to consider the possibility of fraudulent exemption claims which may occur due to the waiver of the annual Income Statement requirement; and

WHEREAS, the requirement that property owners receiving these automatically-renewed exemptions notify the Property Appraiser promptly whenever the property loses its eligibility for the exemption, together with the Property Appraiser's ability to lien a property retroactively for 10 years with penalties and interest if such an exemption is wrongfully obtained or carried over, limit the possibility and consequences of fraudulent exemptions,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board adopts the foregoing recitals, and:

Section 1. After an initial application for exemption has been made and the exemption granted pursuant to section 196.101, the requirement that an annual Income Statement be submitted to the Property Appraiser for exemption of property within the County is hereby waived, except as provided below.

Section 2. Timely annual application together with the required Income Statement for exemption shall be required whenever property exempted on the assessment roll of the immediately preceding tax year is sold or otherwise disposed of, when the ownership changes in any manner, when the applicant ceases to use the property as his or her homestead, or when the status of the owner changes so as to change the exempt status of the property, as provided in section 196.011(9)(a). This resolution shall become effective immediately and shall apply to the

2013 assessment roll and to the assessment roll of each year thereafter until this resolution is rescinded by the Board of County Commissioners.

Section 3. This Board urges the Property Appraiser to mail an annual renewal notice to any property to which the waiver in this Resolution is applied providing the property owner(s) with information regarding the exemptions currently being applied to their property and the potential consequences of an improperly renewed exemption.

The foregoing resolution was offered by Commissioner **Sally A. Heyman**, who moved its adoption. The motion was seconded by Commissioner **Audrey Edmonson** and upon being put to a vote, the vote was as follows:
