

RESOLUTION APPROVING THE CITY OF NORTH MIAMI  
CODESIGNATION OF EMERALD DRIVE WITHIN THE CITY  
OF NORTH MIAMI AS "CHIEF KENNETH EACH DRIVE"

**WHEREAS**, on September 11, 2012, the Mayor and City Council of the City of North Miami adopted Resolution No. R-2012-105 which codesignated Emerald Drive within the City of North Miami as "Chief Kenneth Each Drive," in recognition of his contributions to the City of North Miami, a copy of which is attached and incorporated by reference, and

**WHEREAS**, Kenneth Each entered the City of North Miami Police Department in 1970 and during his tenure with the Police Department, Chief Each served as a patrol officer, detective, patrol sergeant, training and planning sergeant, traffic and special operations sergeant, patrol lieutenant, staff lieutenant and division commander, until he was appointed as the Chief of Police in 1991; and

**WHEREAS**, since his retirement from the North Miami Police Department, Chief Each continues to contribute to the City of North Miami by serving on various boards, such as the Charter Board, Community Redevelopment Agency Committee, Nuisance Abatement Board, and Planning Commission; and

**WHEREAS**, in addition to his substantial years of service in the North Miami Police Department, Chief Each also served this country in the United States Army, and was awarded numerous accolades including the Purple Heart and the Vietnamese Cross of Gallantry with Silver Star; and

**WHEREAS**, Emerald Drive within the City of North Miami is a city street located in the City of North Miami; and

**WHEREAS**, the City of North Miami wants the County to install signage indicating this codesignation on County street signs and traffic signal masts arms; and

**WHEREAS**, this codesignation is located in County Commission District 2,

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA**, that this Board:

**Section 1.** Approves the City of North Miami codesignation of Emerald Drive within the City of North Miami as “Chief Kenneth Each Drive.”

**Section 2.** Directs the Clerk of the Board to send certified copies of this Resolution to the City Manager of the City of North Miami, the City of North Miami Police Department, the United States Postal Service, the Miami-Dade County Fire-Rescue Department, the Traffic Signals and Signs Division of the Public Works and Waste Management Department, and the Development Services Division of the Regulatory and Economic Resources Department.

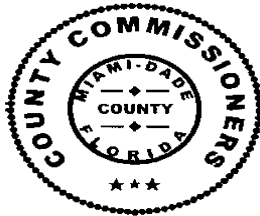

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA, DESIGNATING EMERALD DRIVE TO BE KNOWN AS "CHIEF KENNETH EACH DRIVE"; AUTHORIZING THE CITY MANAGER TO ALLOCATE AND EXPEND THE NECESSARY FUNDS TO COVER THE COSTS FOR SIGNAGE, AND DO ALL THINGS NECESSARY TO EFFECTUATE THE DESIGNATION; PROVIDING FOR AN EFFECTIVE DATE AND ALL OTHER PURPOSES.**

**WHEREAS**, Kenneth Each entered the City of North Miami Police Department in 1970 and during his tenure with the Police Department, Chief Each has served as a patrol officer, detective, patrol sergeant, training and planning sergeant, traffic and special operations sergeant, patrol lieutenant, staff lieutenant, division commander, until he was appointed as the Chief of Police in 1991; and

**WHEREAS**, the Mayor and City Council desire to authorize the City Manager to allocate and expend the necessary funds to cover the costs of any and all signs to indicate the designation of said drive as "CHIEF KENNETH EACH DRIVE."


**NOW THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF NORTH MIAMI, FLORIDA:**

**Section 1. Approval of Street Designation.** The Mayor and City Council of the City of North Miami, Florida, hereby designate Emerald Drive to be known as "CHIEF KENNETH EACH DRIVE."


