Subject: Authorizing Competitive Contract Modifications Using Charter County Transportation  
Surtax Funds

**Recommendation**

It is recommended that the Board of County Commissioners (Board) approve the attached contract modifications with authority to exercise options-to-renew (OTRs). The recommended modifications are described below and in more detail in the accompanying attachments:

**Item 1 – Uniforms & Accessories for Miami-Dade Transit:** Modifies this contract for an additional \$337,000 in spending authority so that Miami-Dade Transit (MDT) can continue to purchase uniforms for its Bus and Rail personnel through the end of the contract term.

**Item 2 – Oil/Water Separation Equipment Maintenance/Repair:** Modifies this contract for an additional six months and \$227,000 in spending authority to allow MDT to purchase oil/water separation equipment, maintenance and repair services for filtration systems inside storm water catch basins.

**Item 3 – Paint and Paint Related Products:** Modifies this contract for an additional \$228,000 in spending authority so that MDT may consolidate its purchases of paint and paint related products onto this contract.

**Item 4 – Security Gates Services:** Modifies this contract to add an additional \$26,000 in spending authority to allow MDT to purchase maintenance and repair services for security gates at various Miami-Dade County locations.

**Item 5 – Contract Employee Services:** Modifies this contract for an additional \$265,000 in spending authority to allow MDT to provide additional contract employee support for operational needs at the new Miami International Airport Station.

**Item 6 – Casters and Industrial Wheels:** Modifies this contract for an additional \$24,000 in spending authority so that MDT can continue to purchase casters and industrial wheels to use on mobile machines and equipment in its repair shops.

This contract award and modifications package is placed for Committee review pursuant to Miami-Dade County Code Section 29-124(f). These contract modification recommendations may only be considered by the Board if the Citizens' Independent Transportation Trust (CITT) has forwarded a recommendation to the Board prior to the date scheduled for Board consideration or 45 days have elapsed since the filing with the Clerk of the Board of this contract award recommendation. If the CITT has not forwarded a recommendation and 45 days have not elapsed since the filing of this award recommendation, I will request a withdrawal of this item. The contracts in this package are scheduled for the November 2012 CITT meeting.

**Scope**

The impact of the items in the Competitive Contract Modifications Package is countywide in nature.

**Fiscal Impact/Funding Source**

The allocation and funding source, by department, is listed in the attached Competitive Contract Modifications Package. Some of the modifications included in this item utilize Charter County Transportation Surtax funding.

Contract amounts and department allocations represent the maximum spending authority based on past utilization. This action does not guarantee that the total contract amount/value will be expended by County departments/agencies. Funding will be expended only if departmental budgets can support the expenditures approved in their annual budget adopted by the Board.

**Track Record/Monitor**

There are no known performance/compliance issues with the vendors recommended for award in the Competitive Contract Modifications Package. Each department's contract manager is reflected in the attached item.

**Delegated Authority**

If this item is approved, the County Mayor or County Mayor's designee will have the authority to exercise, in their discretion, subsequent options-to-renew periods and extend contracts for purchase of goods and services in accordance with the terms and conditions of each contract.

**Due Diligence**

Due diligence was conducted in accordance with the Internal Services Department's Procurement Guidelines to determine Contractor responsibility, including verifying corporate status and review of performance or compliance issues. The lists that were referenced include: convicted vendors, debarred vendors, delinquent contractors, suspended vendors, and federal excluded parties. There were no adverse findings relating to Contractor responsibility. This information is being provided pursuant to Resolution R-187-12.

**Contract Description and Reason for Change:**  
 Miami-Dade Transit (MDT) utilizes this contract to purchase uniforms for MDT Bus and Rail personnel as part of the collective bargaining agreement with the Transport Workers Union. These employees receive an annual allowance for uniforms. The original contract allocation was based on the number of MDT personnel that were entitled to the uniform allowance at the time of contract award. Since that time, there have been three graduating classes of new bus operators that were provided the uniform allowance. As a result, the allocation under this contract needs to be increased to ensure MDT is able to meet its annual uniform allowance requirements through the end of the contract term.

**Contract Description and Reason for Change:**  
 This contract is primarily utilized by Miami-Dade Transit (MDT) and the Internal Services Department for the purchase of oil/water separation equipment, maintenance and repair services for filtration systems inside storm water catch basins. The County's Storm Water Pollution Prevention Plan and the National Pollutant Discharge Elimination System permits require the proper maintenance of catch basin drains as well as annual sampling and analysis of storm water run-off. A successor contract is in the solicitation phase and is expected to be awarded within the next six months. As such, a six-month extension and \$227,000 is being requested to ensure operational continuity while the successor contract is awarded.

**Contract Description and Reason for Change:**

This is a prequalification contract for the purchase of caster and industrial wheels. Miami-Dade Transit (MDT) uses this contract to replace old wheels and casters on storage cabinets, carts, hydraulic lift wheels, shop chairs, and other mobile equipment and machines throughout its repair shops. Due to higher than expected replacement of casters and wheels, MDT's annual spending during the first two years of this contract has been higher than originally originally projected. As a result, it is necessary to modify this contract for additional funding to ensure supply continuity through the remainder of the contract term.
