Subject: Resolution approving the Plat for TARAMAJO SUBDIVISION

**Recommendation**

The following plat is hereby submitted for consideration by the Board of County Commissioners for approval. This plat is bounded on the north approximately 300 feet south of SW 58 Street, on the east approximately 170 feet west of SW 97 Court, on the south by SW 60 Street, and on the west approximately 300 feet east of SW 99 Avenue. The Miami-Dade County Plat Committee, comprised of representatives from the Florida Department of Transportation, the Florida Department of Health, the Miami-Dade County School Board and Miami-Dade County Departments of Fire Rescue, Parks, Recreation and Open Spaces, Regulatory and Economic Resources, Public Works and Waste Management, and Water and Sewer, recommends approval and recording of this plat.

**Scope**

This plat is located within the boundaries of Commission District 10.

**Fiscal Impact /Funding Source**

There is no associated fiscal impact to Miami-Dade County with the approval of this plat; all improvements are in place.

**Track Record/Monitor**

The Regulatory and Economic Resources Department, Development Services Division, administers the processing of plats and waivers of plat, and the person responsible for this function is Raul A. Pino, P. L. S.

- This plat meets concurrency


**Plat Restrictions**

- That SW 60 Street, as illustrated on the plat, together with all existing and future planting, trees, shrubbery and fire hydrants thereon, are hereby dedicated to the perpetual use of the public for proper purposes, reserving to the dedicators, their successors or assigns, the reversion or reversions thereof whenever discontinued by law.
- That individual wells shall not be permitted within this subdivision, except for swimming pools, sprinkler systems and/or air conditioners.

- That the use of septic tanks will not be permitted on any lot within this subdivision, unless approved for temporary use, in accordance with County and State regulations.
- That all new electric and communication lines, except transmission lines, within this subdivision, shall be installed underground.
- That the 10 feet utility easement at the front, rear and sides of certain lots, depicted by dashed lines on the plat, are hereby reserved for the installation and maintenance of public utilities.

**Developer's Obligation**

- None, all improvements are in place.

RESOLUTION APPROVING THE PLAT OF TARAMAJO SUBDIVISION, LOCATED IN THE NORTHEAST 1/4 OF SECTION 29, TOWNSHIP 54 SOUTH, RANGE 40 EAST (BOUNDED ON THE NORTH APPROXIMATELY 300 FEET SOUTH OF SW 58 ST., ON THE EAST APPROXIMATELY 170 FEET WEST OF SW 97 COURT, ON THE SOUTH BY SW 60 STREET, AND ON THE WEST APPROXIMATELY 300 FEET EAST OF 99 AVENUE)

**WHEREAS**, Joe Alba, Mayda Machado, and Tatiana Marie Alba, have this day presented to this Board a plat of certain lands lying in Miami-Dade County, Florida, said plat to be known as TARAMAJO SUBDIVISION, the same being a replat of a portion of Tract 30 of "Miller Drive Estates 1<sup>st</sup> Addition", according to the plat thereof, as recorded in Plat Book 48, at Page 16, of the Public Records of Miami-Dade County, Florida, lying and being in the Northeast 1/4 of Section 29, Township 54 South, Range 40 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said plat insofar as the authority of this Board is concerned have been complied with,

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA**, that said plat is hereby approved; that the dedication of the streets, alleys and other rights-of-way however designated or depicted on said plat is hereby accepted; that the Miami-Dade County Plat Restrictions as listed on said plat are approved and are to be enforced; that approval of the plat is not a waiver of any zoning regulations and that the requirements of the zoning existing on this land at the time this Resolution is approved shall be enforced whether or not the various parcels on this plat conform to those requirements; this approval is conditioned upon the proper execution of all documents required by the County Attorney's Office.

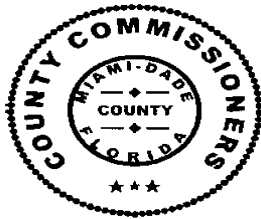

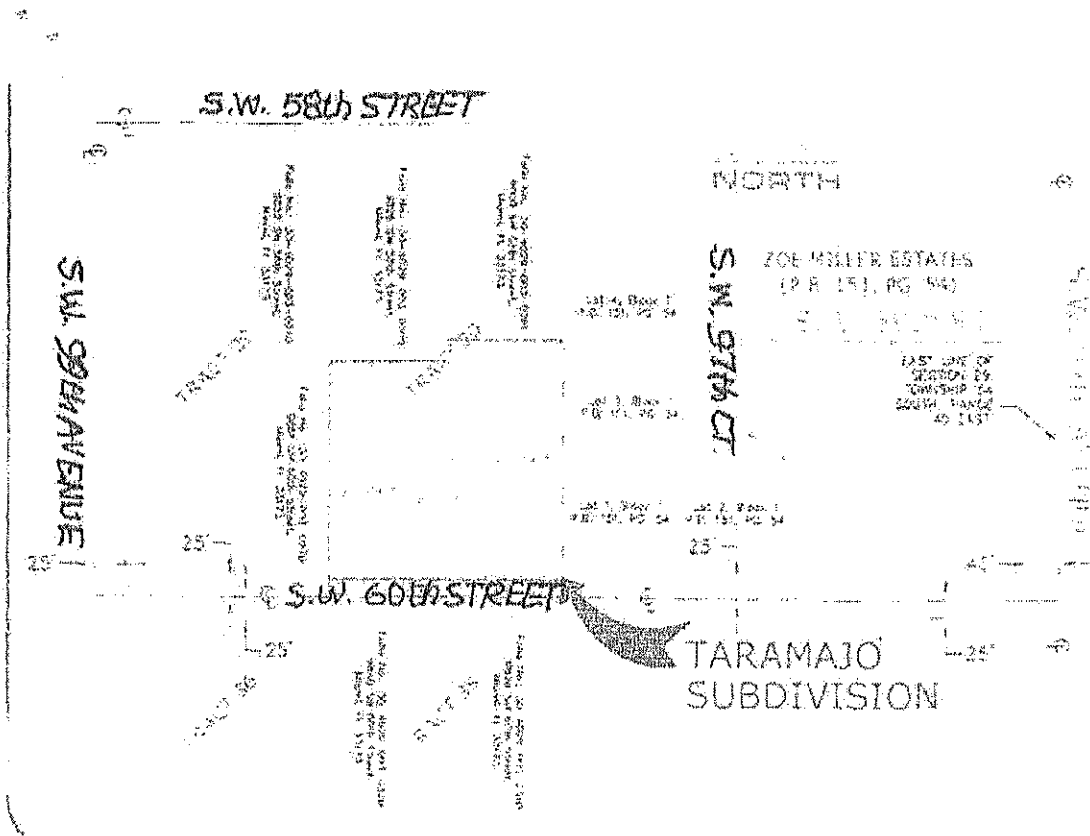
