Recommendation

It is recommended that the Board of County Commissioners (Board) take the following actions for appointments of Agricultural Practices Advisory Board members:

- Appoint Ivonne Alexander to represent the Nursery Industry (Seat #2) as recommended by the Florida Nursery, Growers and Landscape Association; and
- Reappoint James S. Humble as the At-Large representative as recommended by the Agricultural Practices Board.

Scope

The Agricultural Practices Advisory Board has a countywide impact.

Fiscal Impact/Funding Source

There is no fiscal impact to the County.

Track Record/Monitor

Mark Woerner, Assistant Director in the Department of Regulatory and Economic Resources, oversees staff support of the Agricultural Practices Advisory Board.

Background


The Agricultural Practices Advisory Board consists of thirteen members representing a variety of agricultural industries. Section 2-935, Code of Miami-Dade County, requires that the Board fill vacancies occurring on the Agricultural Practices Advisory Board. By Code, each nominating organization must submit for Board review a minimum of one nominee for their vacant position(s), the nominee's resume and the minutes of the organization's meeting at which the nominee was selected. The required documentation for each of the nominees is attached.

- Nursery Industry Representative (Seat 2 of 2)
Ms. Ivonne Alexander was nominated by the Florida Nursery, Growers and Landscape Association as their nominee for the appointment. Ms. Alexander is currently the Chief Financial Officer of Nature's Way Nursery of Miami, Inc. and Happy Days Nursery, Inc. Ms. Alexander previously served on the Agricultural Practices Advisory Board, and has been the Director of the Dade County AgriCouncil, Dade County Farm Bureau, Dade County Fair and Exposition Association, and the Southern Florida Tropical Growers Association among others. The Florida Nursery, Growers and Landscape Association recommended the appointment of Ivonne Alexander at their November 14, 2012 meeting.

- At-Large Representative

Mr. James S. Humble was nominated by the Agricultural Practices Advisory Board to serve as their At-large Representative. Mr. Humble has served as the At-large Representative since 2004, most recently as the Agricultural Practices Advisory Board Chair, and is also a member of the South Florida Water Management District Water Resources Advisory Committee. Mr. Humble has also served on the Combined Structural and Operating Plan Advisory Committee and the Florida Department of Agriculture's Agricultural Advisory Committee. Mr. Humble is the owner of PITA Groves in South Miami-Dade County. The Agricultural Practices Advisory Board recommended the reappointment of James S. Humble at their November 7, 2012 meeting.

The terms for the appointment and reappointment begin on January 1, 2013 and will expire on December 16, 2016.

WHEREAS, Sections 2-931 through 2-936 of the Code of Miami-Dade County provides for the creation, composition, terms, purpose and duties of the Agricultural Practices Advisory Board; and

WHEREAS, Section 2-933 of the Code of Miami-Dade County specifically provides for the designated organizations to recommend at least one nominee; and

WHEREAS, the Florida Nursery, Growers and Landscape Association has recommended Ms. Ivonne Alexander to serve as the Florida Nursery, Growers and Landscape Association Representative Seat #2 on the Agricultural Practices Advisory Board; and

WHEREAS, Mr. James S. Humble completed his second term as the At-large Representative on the Agricultural Practices Advisory Board and is eligible for a third term; and

WHEREAS, the Agricultural Practices Advisory Board has recommended Mr. James S. Humble to a third term as the At-large Representative on the Agricultural Practices Advisory Board; and

WHEREAS, Section 2-935 of the Code of Miami-Dade County directs that vacancies on the Agricultural Practices Advisory Board shall be filled by the Board of County Commissioners,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that with respect to the Agricultural Practices Advisory Board, Ms. Ivonne Alexander is hereby appointed to the Florida

Nursery, Growers and Landscape Association Representative Seat #2, and Mr. James S. Humble is hereby reappointed for a second term to the At-large Representative seat. Each individual listed above is hereby appointed to serve one four-year term beginning on January 1, 2013 and ending on December 31, 2016.

Chair James Humble called the meeting to order at 9:15 AM.

Reports

Chair's Report

Chair Humble stated that the County Attorney's Office should follow the APAB ordinance, as adopted by the BCC, rather than make its own interpretation regarding the appointment of an At-large member to the APAB. Chair Humble passed the Chairmanship to Vice Chair Caudle to lead the meeting. Mr. Dorsey reminded the APAB that the County Code states that the Chair shall be nominated at the end of the calendar year, thus, Chair Humble is technically the Chair until the end of the December.

Coordinator's Report

Mr. Mark Dorsey announced he had received four applications for reappointment and is waiting for the Coalition of Florida Farmworkers to submit its nominee(s) for appointment. Mr. Dorsey said he overlooked Mr. Sandy Stein's reappointment to the APAB, since he completed the remainder of Mr. Jorge Abreu's term; Mr. Dorsey has since contacted the Florida Nursery, Growers and Landscape Association (FNGLA) to inform them of Mr. Stein's eligibility for reappointment. Mr. Dorsey also said he had not received applications for the At-large Representative seat by the October 26th deadline, thus the APAB could nominate Mr. Humble, or another candidate, to the At-large seat. However, the Planning Division would still need the candidate's resume showing that 50% or more of their income is derived from agriculture, as required by the Code. Mr. Dorsey said he will be absent for the December meeting and Mr. Napoleon Somoza, Section Supervisor, will staff the meeting.

Agricultural Patrol Report

Lt. Sheree DiBernardo reported that Agricultural Patrol officers responded to 114 calls for service during the month of October 2012 and made 22 arrests. A total of 251 arrests have been made for the year. There were 21 thefts in October, up from 12 in September. Thefts included: stolen pots, of which a suspect was arrested; lawn equipment and small tangibles from nurseries; 1 Kubota Recreational Terrain Vehicle (RTV), several of which have been stolen over the last two months; 1 Bobcat; one avocado theft; banana thefts; pigeon and sheep thefts; and beehive thefts. Lt. DiBernardo suggested that golf carts, all-terrain vehicles, and other motorized vehicles should be placed inside a barn or garage, as those that are exposed or left unattended are most likely to be stolen. She also said the most frustrating problem Police continue to face is brass sprinkler thefts. Four were reported last month and 2 large thefts have been reported so far this month; she said a suspect was being interviewed this morning. Lt. DiBernardo stated that recycling centers are no longer reporting sprinkler heads thefts, as they initially did, as the criminals may have began reselling stolen goods to recyclers outside of Miami-Dade County.

Board members discussed the issue of stolen brass sprinkler heads and crime in the agricultural area and asked how many Police are on staff. Lt. DiBernardo said there are now approximately 8 officers in the unit. Board members suggested sending a letter to the Mayor and BCC to request more staffing for the Agricultural Patrol unit to combat crime in the agricultural community. Ms. Debbie Brady, Dade County Farm Bureau (DCFB), said they may insert a petition in their newsletter for recipients to sign and return to the DCFB. The Board also discussed having other organizations submit a letter to the Mayor and BCC. Chair Humble made motion to draft a letter to the Mayor and BCC; Board Member DeMott seconded the motion. The Board voted unanimously to draft a letter to request additional staffing for the Agricultural Patrol.

Agricultural Manager's Report

Mr. Charles LaPradd announced that the Wetlands Advisory Taskforce (WATF) will meet on November 8th, and said that he will provide an update at the next meeting. This Friday, November 9th, he will meet with representatives from the Florida Department of Agriculture and Consumer Services (FDACS) and the County's Division of Environmental Resources Management (DERM) to discuss wetlands issues. Mr. LaPradd stated that he met with Zoning and DERM staff yesterday, November 6th, regarding the approval of agricultural uses on lots less than 5 acres in size. Agricultural uses are currently prohibited on these lots unless they are grandfathered or handled administratively. The proposed changes will be codified into the County Code.

Board Member Dufek questioned how the County could prohibit any use on lots less than 5 acres in size when the State statute does not require a minimum lot size. Mr. LaPradd said the referenced statute, Section 193.461 F.S., refers to taxation and is separate from zoning. A lot can be used for and receive an agricultural classification for tax purposes, but Code Enforcement could fine the owner for operating in violation of the Zoning Code. He said the current regulations require a 5-acre minimum lot size for any use of property outside the UDB except for grandfathered lots. The proposed code language would only allow some residential, with covenants, and agricultural uses.

Chair Humble said he and Mr. LaPradd met with DERM staff regarding the APAB's recommendation to the BCC to amend the County Code so that agricultural exemptions are consistent with State agricultural exemptions. That has not yet happened. He added that the wetland mitigation fee to convert wetlands to agriculture is currently \$85,000 per acre, yet developers who purchase the same property are exempt from the same wetland mitigation fee. He said the law is imbalanced to favor developers over farmers and should be changed. Mr. LaPradd said the problem is that Chapter 24 of the County Code defines agriculture as development.

Cooperative Extension Manager's Report

Ms. Teresa Olczyk said the hiring of a Tropical Fruit agent is undergoing the approval process and the County has to create the position. She hopes the University (of Florida) will be able to advertise the position in January 2013. Ms. Olczyk announced that today's "Train the Trainers" program has been

moved to November 27th. A "Green Industry Best Management Practices" workshop (in Spanish) for persons applying commercial fertilizers will be held on November 8th; this workshop is consistent with State law. A conference on the implementation of better nutrition standards and introduction of local produce to school children will be held on November 13th. And a Thanksgiving luncheon will be held at the Agricultural Center on November 14th from 3:00 - 6:30PM.

New Business

Nomination of At-large Representative

Board Member Tietig made a motion to nominate Chair James Humble as the At-large Representative to the APAB; the motion was seconded by Board Member DeMott. There was no discussion on the motion. The motion was passed unanimously and was approved by an 8-0 vote as follows:

Unfinished Business

Board Member Motes took exception to the characterization of his request from the Property Appraiser office regarding the elimination of outliers in the data request. Mr. Elmer Fernandez, Office of the Property Appraiser (OPA), said he had provided Board Member Motes with the median, but could separate them into categories of 0.0-5.0 acres and provide the median and mode, and from 5.0-7.5 acres, etc. He said it is difficult to exclude the "outliers" (the top 10 and lowest 10) from the research. Board Member Motes said his request is to develop an accurate analysis of the nature of agriculture and horticulture in Miami-Dade County. He believes the APAB may no longer represent the type of agriculture that currently exists; therefore, removing the outliers from the data (a common practice) may provide a more accurate representation of local agriculture.

Chair Humble agreed that agriculture changes over time but felt that all farmers, regardless of size, should be included in the data. Board Member Tietig suggested that the standard deviation would clearly show average farm size as well as the outliers. Mr. Don Pybus said the 2007 Agricultural Census data reported that 72% of Miami-Dade County farms were less than 5-acres. He said farm size can be looked at in terms of size or the value of sales; the USDA defines small farms as having less than \$250,000 in sales. Board Member Motes believes that Miami-Dade agriculture may better be defined as horticulture, which has the more intense profit per sq.ft./acre than traditional crops. Board Member DeMott said only Ferns, Hibiscus and Mandevilla/Dipladenia hybrids can be grown with enough volume to be considered a crop. He defined a crop as a monoculture; but did not understand the purpose of the research. Board Member Motes said he wants to know the percentage of the economic impact of small farmers in order to direct County services to support the industry. Vice-Chair Caudle said the majority of APAB members are small farmers. He said crops include horticulture, as well as corn, tomatoes and beans; although Miami-Dade doesn't compare to larger producers we have an important, multifaceted crop industry. Board Member Thompson suggested that small farmers should meet and present their concerns to the APAB rather than the APAB imposing its perception of needs to the community.

Mr. Fernandez said he will provide the standard deviation for all 8,300 parcels that receive an agricultural exemption. Mr. LaPradd added that the United States Department of Agriculture (USDA) defines all

nursery crops as harvestable agricultural crops, and the State defines agricultural crops as a plants or animals useful to humans.

Public Comment/Board Announcements

Ms. Rebecca Elliott, Florida Department of Agriculture and Consumer Services, Office of Agricultural Water Policy, announced that the South Florida Water Management District (SFWMD) has begun "operational calls" regarding seasonal operations for the Military, C-102 and C-103 canals. The phone calls include stakeholders who advise the District on operational improvements and environmental sensitivity to Biscayne Bay; the first call will be held today at 1:00PM. Ms. Elliott will forward the information to Mr. Dorsey for distribution.

Ms. Johanna Faddis, Commissioner Bell's Office, announced that Commissioner Bell is working on certain items that came about as a result of the Wetlands Advisory Taskforce. Ms. Faddis will seek comments from the APAB at a later date. She said that Commissioner Bell has received and will sponsor the APAB member re-appointment requests. Ms. Faddis concluded by saying that Commissioner Bell wanted to express her thanks to the APAB and others for having received a Dade County Farm Bureau award.

Ms. Debbie Brady, Dade County Farm Bureau (DCFB), announced that former DCFB member and long time farmer Dick Natoli passed on November 4th; services will be held on November 8th at 11:30AM at Branam Funeral Home. Ms. Brady also announced the following winners in the Florida House of Representatives: Katie Edwards in District 98, Jake Raburn (a Florida Farm Bureau member) in District 57, and Holly Raschein in District 120.

Ms. Martha Garcia, Environment and Regulatory Affairs (RER), announced that she is available to address questions regarding the Wetlands Advisory Taskforce, wetland mitigation and permitting. Ms. Garcia also clarified that wetland mitigation fees are based on a property's biological and numerical analysis according to environmental quality. Although the set value per credit is \$85,000, the quality of a property is typically only ¼ credit or \$20,000 per acre.

Adoption of Minutes


