RESOLUTION NO. R-01-13

RESOLUTION CODESIGNATING NW 175 STREET FROM
NW 27 AVENUE TO NW 12 AVENUE AS "REVEREND
DR. G. DAVID HORTON BOULEVARD"

WHEREAS, on December 12, 2012, the City Council of the City of Miami Gardens adopted Resolution No. 2012-190-1785, which recommended that Miami-Dade County codesignate NW 175 Street from NW 27 Avenue to NW 12 Avenue as "Reverend Dr. G. David Horton Boulevard", in recognition of Reverend Horton's contributions to the City of Miami Gardens and Miami-Dade County, a copy of which is attached and incorporated by reference; and

WHEREAS, Reverend Dr. G. David Horton has been pastoring in Miami Gardens/Opa-Locka for thirty-two (32) years at Greater New Bethel Missionary Baptist Church; and

WHEREAS, he took the lead in forming the North Dade Community Development Federal Credit Union; and

WHEREAS, he is a proponent of the Unrepresented People's Positive Action Council ("UP-PAC"); and

WHEREAS, Reverend Horton has made valuable contributions to the community for more than three decades, and continues to serve the community in meaningful ways; and

WHEREAS, the Board of County Commissioners would like to honor Reverend Dr. Horton with this codesignation; and

WHEREAS, NW 175 Street from NW 27 Avenue to NW 12 Avenue is a County road located in the City of Miami Gardens; and

WHEREAS, this proposed codesignation is located in County Commission District 1,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Having considered this matter at a public hearing, codesignates NW 175 Street from NW 27 Avenue to NW 12 Avenue as "Reverend Dr. G. David Horton Boulevard".

Section 2. Directs the Clerk of the Board to transmit a certified copy of this resolution to the United States Postal Service, the Mayor of the City of Miami Gardens, the Miami Gardens Police Department, the Miami-Dade County Fire-Rescue Department, the Traffic Signals and Signs Division of the Public Works and Waste Management Department and the Development Services Division of the Department of Regulatory and Economic Resources.

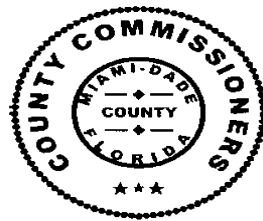

RESOLUTION NO. 2012-190-1785

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, RECOMMENDING THAT MIAMI-DADE COUNTY CO-DESIGNATE NW 175TH STREET FROM NW 27TH AVENUE TO NW 12TH AVENUE, REVEREND DR. G. DAVID HORTON BOULEVARD; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, City Council recently amended Land Development regulations to amend the criteria required for when the City Council considers whether to rename or co-designate a street or to recommend to the state, county or federal government that a street be renamed or co-designated, and

WHEREAS, on December 2012, a request was sent to the City Council requesting that NW 175th Street from NW 27th Avenue to NW 12th Avenue be co-designated as Reverend Dr. G. David Horton Boulevard, and

WHEREAS, NW 175th Street is a county road, and

WHEREAS, in that regard, the county will openly have to determine whether or not to co-designate the street, and

WHEREAS, in accordance with the City's Land Development regulations, the City Council is recommending that NW 175th Street from NW 27th Avenue to NW 12th Avenue be co-designated as Reverend Dr. G. David Horton Boulevard, and

WHEREAS, in accordance with Section 34-233 of the City's Code of Ordinances, streets are only to be recommended for co-designation when persons have demonstrated extraordinary service to the City and its residents, or persons having exceptional credit or recognition to the City and its residents, or persons of significant prominence nationally or internationally, and

WHEREAS, Reverend Dr. G. David Horton has been pastoring in Miami Gardens/Opa- Locka for thirty-two (32) years at Greater New Bethel Missionary Baptist Church, and

WHEREAS, in order for this resolution to be adopted co-designating NW 175th Street, it will require the unanimous consent of the City Council,



Section 2: AUTHORIZATION: The City Council of the City of Miami Gardens hereby recommends that Miami-Dade County co-designate NW 175th Street from NW 27th Avenue to NW 12th Avenue, Reverend Dr. G. David Horton Boulevard.

Section 3: EFFECTIVE DATE: This Resolution shall take effect immediately upon its final passage.
