RESOLUTION NO. R-303-13

RESOLUTION IN SUPPORT OF THE CRUISE INDUSTRY;
AN IMPORTANT ECONOMIC ENGINE AND COMMUNITY
PARTNER

WHEREAS, the cruise industry was founded in Miami-Dade County more than 45 years ago, and is a vital economic contributor to the Miami-Dade economy; and

WHEREAS, Miami-Dade County is the headquarters for four of the world's leading cruise lines: Carnival Cruise Lines, Royal Caribbean Cruises Ltd., Norwegian Cruise Line, and Prestige Cruise Holdings; and

WHEREAS, the cruise industry is committed to very high standards in areas of safety, passenger care, and environmental protection; and

WHEREAS, Florida is the number one cruise state in the nation, accounting for 60% of cruise traffic in the nation; and

WHEREAS, Florida's cruise industry accounted for \$6.7 billion in direct spending in 2011, generating more than 130,000 jobs, and wages totaling \$5.8 billion; and

WHEREAS, PortMiami is the "Cruise Capital of the World," handling approximately 4 million cruise passengers annually; and

WHEREAS, the cruise industry pays millions of dollars in port fees to PortMiami that contribute to the funding of port infrastructure; and

WHEREAS, many County industries benefit from cruise line spending including hotels, restaurants, retail, cultural and sporting events, transportation providers, and travel agencies, among others; and

WHEREAS, the cruise lines operating from PortMiami have been good corporate stewards to the County, through their core business activities, social investment, philanthropy programs, and their involvement in civic activities; and

WHEREAS, PortMiami is the second largest economic engine contributing to the local economy of the County,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board commends and remains supportive of the cruise industry, recognizing its role as a crucial economic engine for Miami-Dade County, one that creates jobs and wealth for Florida’s economy.

The Prime Sponsor of the foregoing resolution is Chairwoman Rebeca Sosa and the Co-Sponsor is Vice Chair Lynda Bell. It was offered by Commissioner **Rebeca Sosa**, who moved its adoption.
