RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARKS, RECREATION AND OPEN SPACES DEPARTMENT FOR THE MARCH 16, 2013 "3W WALK4LIFE: SOWING A SEED" EVENT SPONSORED BY WORSHIP WITHOUT WALLS CHURCH, INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$400.00 TO BE FUNDED FROM THE BALANCE OF THE DISTRICT 9 FY 2012-13 IN-KIND RESERVE FUND

WHEREAS, Worship Without Walls Church, Inc., has requested in-kind services from the Miami-Dade Parks, Recreation and Open Spaces Department for the March 16, 2013 "3W Walk4Life: Sowing a Seed" event in an amount not to exceed \$400.00 (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, the purpose of the "3W Walk4Life: Sowing a Seed" event is to promote exercise and a healthy lifestyle; and

WHEREAS, this event will also encourage and promote volunteerism by engaging young people in our community; and

WHEREAS, the proceeds of this event will be used to cover medical expenses related to three-year old Noah Hernandez who is currently battling leukemia; and

WHEREAS, Worship Without Walls Church Inc. is a not-for-profit organization; and

WHEREAS, "3W Walk4Life: Sowing a Seed" event is a district event, as that term is defined in the attached Fee Waiver/In-kind Service Application, and \$400.00 of the in-kind services shall be funded from the balance of the District 9 FY 2012-13 In-Kind Reserve Fund,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board retroactively authorizes in-kind services from the Miami-Dade Parks, Recreation and Open Spaces Department for the March 16, 2013 “3W Walk4Life: Sowing a Seed” event sponsored by Worship Without Walls Church, Inc., in an amount not to exceed \$400.00 to be funded from the balance of District 9 FY 2012-13 In-Kind Reserve Fund.




