

RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARKS, RECREATION AND OPEN SPACES DEPARTMENT FOR THE MARCH 10, 2013 "CALLE OCHO FESTIVAL 2013" SPONSORED BY THE KIWANIS OF LITTLE HAVANA FOUNDATION, INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$1,750.00 TO BE FUNDED FROM THE BALANCE OF THE DISTRICT 5 FY 2012-13 IN-KIND RESERVE FUND

WHEREAS, the Kiwanis of Little Havana Foundation, Inc. has requested in-kind services from the Miami-Dade Parks, Recreation and Open Spaces Department for the March 10, 2013 "Calle Ocho Festival 2013" in an amount not to exceed \$1,750.00 (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, this international event which celebrates Hispanic culture, attracts visitors from all over the world, promotes the arts and provides funds for community projects; and

WHEREAS, the Kiwanis of Little Havana Foundation, Inc. is a not-for-profit organization; and

WHEREAS, "Calle Ocho Festival 2013" is a major event, as that term is defined in the attached Fee Waiver/In-kind Service Application, and \$1,750.00 of the in-kind services shall be funded from the balance of the District 5 FY 2012-13 In-Kind Reserve Fund,


