Recommendation

The attached Contract Award Recommendation for the People's Transportation Plan (PTP) project entitled *Drainage Improvement Project for Multiple Sites* (Project MCC 7040 Plan - CICC 7040-0/07 Request for Price Quotation No. 20120161) in the amount of \$480,398.18 to GPE Engineering & General Contractor Corp., was prepared by the Public Works and Waste Management Department (PWWM) and is recommended for approval by the Board of County Commissioners (BCC).

This Contract Award Recommendation is placed for Committee review pursuant to Miami-Dade County Code Section 29-124(f). This Contract Award Recommendation may only be considered by the BCC if the Citizens' Independent Transportation Trust (CITT) has forwarded a recommendation to the BCC prior to the date scheduled for BCC consideration or forty-five (45) days have elapsed since the filing with the Clerk of the Board of this contract award recommendation. If the CITT has not forwarded a recommendation and forty-five (45) days have not elapsed since the filing of this award recommendation, I will request a withdrawal of this item.

Scope

The work to be performed under this Contract includes drainage improvements at various locations within Miami-Dade County.

Fiscal Impact/Funding Source

The fiscal impact will be approximately \$480,398.18 and will be funded from Charter County Transportation Surtax Bond Sale Proceeds, QNIP Phase V UMSA Bond Proceeds, and the Stormwater Utility. The base contract amount is \$419,819.80, with the total amount being inclusive of contingency and dedicated allowance amounts. There is no fiscal impact to operations or maintenance.

The proposed improvements qualify under the allowable work categories included in the PTP Neighborhood Improvements Section. The funding index codes for this project are, CPEPTP611DRN, CPEPTP604DRN, CPE316PWDRNG, and CPEQ5PW03DRN (FY 2012-13 Adopted Capital Projects 6037700, 609630 and 6031811).

Delegation of Authority

No additional authority is being requested within the body of this Contract.

Track Record/Monitor

GPE Engineering & General Contractor Corp. has not performed any work for PWWM; however, the Capital Improvements Information System (CIIS) database lists six (6) awarded construction contracts as follows:

- one (1) from the Parks, Recreation and Open Spaces Department, and
- five (5) from the Water and Sewer Department.

The referenced database also lists a total of four (4) contractor performance evaluations with an overall performance rating of 2.7 (satisfactory performance), out of a possible 4.0 (superior performance) rating. The Regulatory and Economic Resources Department, Small Business Development Division (SBD) History of Violation's report lists no violations for this contractor.

According to the Florida Department of State, Division of Corporations, GPE Engineering & General Contractor Corp., Company Principals are Caridad X. Reyes, Antonio Reyes, and Nicasia Gonzalez and the Company's address is listed as 13117 NW 107 Avenue, Hialeah Gardens, Florida 33018.

Following PWWM's standard operating procedures, after award of this Contract a pre-construction meeting will be scheduled. The person responsible for all PTP projects in PWWM is PTP Coordinator, Mr. Alejandro Martinez-Esteve, RA, LEED AP. Following completion of the award process, the project will be assigned to Mr. Leo Salgueiro, Project Coordinator, for day-to-day responsibilities.

Background

As part of the PTP Neighborhood Improvements initiative, PWWM continues to take advantage of various contracting mechanisms such as the Miscellaneous Construction Contracting process available under the MCC 7040 Program. Through this process, PWWM forwards a Request for Price Quotation (RPQ), by way of facsimile transmission, to a pool of pre-qualified Community Small Business Enterprise (CSBE) contractors for the respective trade. Additionally, PWWM advertises the project in the *Daily Business Review* and all solicitations are available on-line through the Miami-Dade County portal under the "Procurement Solicitations" link. The project's award evaluation is based upon the bid submitted by the lowest responsive, responsible bidder for the project.

PWWM staff determined that the scope of work for this project qualified for a CSBE set-aside (Levels I, II, and III). A Community Workforce Program Goal was deemed not applicable to this RPQ. On February 21, 2013, PWWM forwarded an RPQ for the Drainage Improvement Project for Multiple Sites, utilizing the MCC 7040 Plan - CICC 7040-0/07 Contract, to a list of 248 pre-qualified firms. A total of five (5) firms purchased contract documents and eight (8) firms proffered a bid.

On April 8, 2013, Inframaster GC Corp. proffered the lowest bid; however, the firm's bid was deemed non-responsive since they failed to submit the required bid bond as stipulated in the Contract Documents. Therefore, GPE Engineering & General Constructor Corp. proffered the lowest responsive and responsible base bid of \$419,819.80, five (5) percent over the County's cost estimate.

The second lowest bidder, Florida Construction and Engineering, Inc. proffered a base bid of \$423,894.74, one (1) percent over the lowest bidder. The third lowest bidder, Quality Paving Corporation proffered a base bid of \$428,728.00, one (1) percent over the second lowest bidder. Based on the results of the solicitation, PWWM issued a recommendation for award on April 9, 2013 for RPQ No. 20120161 to GPE Engineering & General Contractor Corp., with the stipulation that approval for this project must be obtained from the CITT and the BCC.

The work to be accomplished for this project consists of, but is not limited to, furnishing all supervision, labor, required materials, equipment, and tools to perform all operations necessary for drainage improvements. The work includes construction and installation of drainage structures, french drains, miscellaneous drainage improvements, grading, sodding, and miscellaneous roadway restoration including construction of concrete curb and gutters, and sidewalks where needed in accordance with the construction plans and specifications.

This includes a base contract amount of four hundred nineteen thousand eight hundred nineteen dollars and eighty cents (\$419,819.80), a contingency amount of forty-one thousand nine hundred eighty-one dollars and ninety-eight cents (\$41,981.98), and dedicated allowances totaling eighteen thousand five hundred ninety-six dollars and forty cents (\$18,596.40). The contract duration is established as **150-calendar days**. However, the recommendation of award is contingent upon the submission of the required items listed below:
