RESOLUTION NO. R-500-13

RESOLUTION CODESIGNATING SW 104 STREET FROM SW 97 AVENUE TO SW 102 AVENUE AND KENDALE SOUTH BOULEVARD FROM SW 102 AVENUE TO KILLIAN PARKWAY AS "DAVID LYONS STREET"

WHEREAS, David Emanuel Lyons was born in Kingston, Jamaica in 1930; and

WHEREAS, Mr. Lyons attended Northeastern University in Boston, Massachusetts, where he received a bachelor's degree in chemical engineering; and

WHEREAS, after graduation, Mr. Lyons returned to Jamaica, becoming a very successful businessman; and

WHEREAS, in 1977, due to the political climate in his native country, Mr. Lyons emigrated to the United States, settling in the Kendall area, in Miami, Florida; and

WHEREAS, Mr. Lyons reinvented himself and became a highly successful commodities broker with the International Trading Group; and

WHEREAS, upon retiring from the International Trading Group, Mr. Lyons devoted his time to his own company, Caribex Industries, exporting to Jamaica and other Caribbean countries; and

WHEREAS, in addition to being a successful businessman, Mr. Lyons served his local community as the past President of the Kendale Homeowners Association; and

WHEREAS, David Lyons passed away on December 26, 2012; and

WHEREAS, SW 104 Street from SW 97 Avenue to SW 102 Avenue and Kendale South Boulevard from SW 102 Avenue to Killian Parkway are County roads located in unincorporated Miami-Dade County; and

WHEREAS, this Board would like to honor David Lyons with this codesignation in recognition of the contributions Mr. Lyons made to Miami-Dade County's community; and

WHEREAS, this proposed codesignation is located in County Commission District 7,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Having considered this matter at a public hearing, codesignates SW 104 Street from SW 97 Avenue to SW 102 Avenue and Kendale South Boulevard from SW 102 Avenue to Killian Parkway as "David Lyons Street".

Section 2. Directs the Clerk of the Board to transmit a certified copy of this resolution to the United States Postal Service, the Traffic Signals and Signs Division of the Public Works and Waste Management Department, the Development Services Division of Regulatory and Economic Resources Department, the Miami-Dade Police Department, and the Miami-Dade Fire Rescue Department.

The Prime Sponsor of the foregoing resolution is Commissioner Xavier L. Suarez. It was offered by Commissioner **Xavier L. Suarez**, who moved its adoption. The motion was seconded by Commissioner **Audrey Edmonson** and upon being put to a vote, the vote was as follows:
