Resolution No. R-616-13

Recommendation

The following waiver of plat is hereby submitted for consideration by the Board of County Commissioners for approval. This plat is bounded on the north approximately 200 feet south of SW 226 Street, on the southeast by US No. 1 (State Road No. 5), on the south approximately 330 feet north of SW 228 Street, and on the northwest by the Busway. The Miami-Dade County Plat Committee, comprised of representatives from the Florida Department of Transportation, the Florida Department of Health, the Miami-Dade County School Board and Miami-Dade County departments of Fire Rescue, Parks, Recreation and Open Spaces, Regulatory and Economic Resources, Public Works and Waste Management (PWWM), and Water and Sewer, recommends approval of this waiver of plat.

Scope

This waiver of plat is located within the boundaries of Commission District 9, Commissioner Dennis C. Moss.

Fiscal Impact/Funding Source

There is no associated fiscal impact to Miami-Dade County with the approval of this waiver of plat; all improvements are in place.

RESOLUTION APPROVING THE WAIVER OF PLAT OF JORGE, AMPARO AND ISABEL DEL PINO, D-23374, LOCATED IN THE SOUTHWEST 1/4 OF SECTION 13, TOWNSHIP 56 SOUTH, RANGE 39 EAST (BOUNDED ON THE NORTH APPROXIMATELY 200 FEET SOUTH OF SW 226 STREET, ON THE SOUTHEAST BY US NO. 1/STATE ROAD NO. 5, ON THE SOUTH APPROXIMATELY 330 FEET NORTH OF SW 228 STREET, AND ON THE NORTHWEST BY THE BUSWAY)

WHEREAS, Jorge and Amparo del Pino, as single persons, and Isabel del Pino, a married woman, have this day presented to this Board a waiver of plat of certain lands lying in Miami-Dade County, Florida, said waiver of plat of the property legally described as a parcel of land lying and being in the Southwest 1/4 of Section 13, Township 56 South, Range 39 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said waiver of plat insofar as the authority of this Board is concerned have been complied with,


