

RESOLUTION NO. R-604-13

RESOLUTION APPROVING THE CITY OF SOUTH MIAMI
CODESIGNATIONS OF CERTAIN MUNICIPAL STREETS
WITHIN THE CITY OF SOUTH MIAMI IN HONOR OF CITY
PIONEERS

WHEREAS, on September 3, 2002, the City Commission of the City of South Miami adopted Resolution No. 126-02-11475 which codesignated certain municipal streets in recognition of the contributions to the City of South Miami of various city pioneers, a copy of which is attached and incorporated by reference; and

WHEREAS, John F. M. Burtashaw, Robert W. and Harold W. Dorn, J. W. Dowling, John J. Hinson, Wilson A. Larkins, Regina Lawrence, Helen Miller Margolin, John Opsahl, Marshall Williamson, J. L. Yarborough, and Paul U. Tevis, some of whom in addition to being among the first settlers, were merchants and political figures who were important catalysts for the City's early economy; and

WHEREAS, the following streets are all city streets located within the City of South Miami:

- SW 62 Avenue from Bird Road to Miller Drive as "Burtashaw Avenue",
- SW 59 Avenue from US 1 to Snapper Creek as "Dorn Avenue",
- SW 60 Street to SW 60 Avenue East as "Dowling Street",
- SW 68 Street from SW 57 Avenue to SW 69 Avenue as "Hinson Street",
- SW 71 Street from US 1 to SW 58 Avenue as "Margolin Street",
- SW 58 Avenue from US 1 to Snapper Creek as "Larkins Avenue",
- SW 60 Avenue from SW 62 Street to SW 66 Street as "Marshall Williamson Avenue",
- SW 58 Court from US 1 To Snapper Creek as "Opsahl Avenue",
- SW 66 Street from SW 57 Avenue to SW 67 Avenue as "Regina Lawrence Street",
- SW 69 Street from SW 58 Place to SW 64 Avenue as "Yarborough Street", and
- SW 62 Avenue from Miller Drive to SW 87 Street as "Tevis Drive"; and

WHEREAS, the City of South Miami wants the County to install signage indicating the above-referenced codesignations on County street signs and traffic signal masts arms; and

WHEREAS, these codesignations are located in County Commission District 7,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Approves the following City of South Miami codesignations:

- SW 62 Avenue from Bird Road to Miller Drive as “Burtshaw Avenue”,
- SW 59 Avenue from US 1 to Snapper Creek as “Dorn Avenue”,
- SW 60 Street to SW 60 Avenue East as “Dowling Street”,
- SW 68 Street from SW 57 Avenue to SW 69 Avenue as “Hinson Street”,
- SW 71 Street from US 1 to SW 58 Avenue as “Margolin Street”,
- SW 58 Avenue from US 1 to Snapper Creek as “Larkins Avenue”,
- SW 60 Avenue from SW 62 Street to SW 66 Street as “Marshall Williamson Avenue”,
- SW 58 Court from US 1 To Snapper Creek as “Opsahl Avenue”,
- SW 66 Street from SW 57 Avenue to SW 67 Avenue as “Regina Lawrence Street”,
- SW 69 Street from SW 58 Place to SW 64 Avenue as “Yarborough Street”, and
- SW 62 Avenue from Miller Drive to SW 87 Street as “Tevis Drive”.

Section 2. Directs the Clerk of the Board to send certified copies of this Resolution to the Mayor and City Manager of the City of South Miami, the United States Postal Service, the Traffic Signals and Signs Division of the Public Works and Waste Management Department, the Development Services Division of the Regulatory and Economic Resources Department, the City of South Miami Police Department, and the Miami-Dade County Fire Rescue Department.

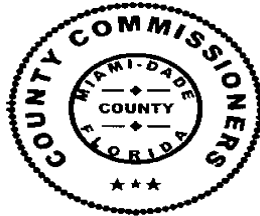

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF SOUTH MIAMI, FLORIDA TO HONOR SEVERAL CITY PIONEERS BY CO-NAMING SEGMENTS OF CITY STREETS AFTER THEM. AUTHORIZING THE CITY MANAGER TO DISBURSE THE SUM OF \$5,600.00 TO MIAMI DADE FOR THE INSTALLATION OF SAID SIGNS AND CHARGING THE DISBURSEMENT TO ACCOUNT NO. 001-0000-219-1130, "HISTORIC PRESERVATION BOARD ACCOUNT".

WHEREAS, John F. Burtshaw, Harold and Robert W. Dorn, J. W. Dowling, W. A. Foster, John J. Hinson, Wilson A. Larkin, Regina Lawrence, Helen Miller Margolin, John Opsahl, Marshall Williamson J. L. Yarborough, Paul Tavis were pioneering South Miami individuals who through their time, effort, and resources helped to develop, nurture and improve the city, and;
