### Recommendation

The following plat is hereby submitted for consideration by the Board of County Commissioners for approval. This plat is bounded on the north by NW 21 Lane, on the east by NW 133 Avenue, on the south approximately 600 feet north of NW 17 Street, and on the west approximately 460 feet east of NW 137 Avenue. The Miami-Dade County Plat Committee, comprised of representatives from the Florida Department of Transportation, the Florida Department of Health, the Miami-Dade County School Board and Miami-Dade County Departments of Fire Rescue, Parks, Recreation and Open Spaces, Regulatory and Economic Resources (RER), Public Works and Waste Management (PWWM), and Water and Sewer, recommends approval and recording of this plat.

### Scope

This plat is located within the boundaries of Commission District 12, Commissioner Jose "Pepe" Diaz.

### Fiscal Impact/Funding Source

There is no associated fiscal impact to Miami-Dade County with the approval of this plat; all improvements are in place.

### Track Record/Monitor

RER, Development Services Division, administers the processing of plats and waivers of plat, and the person responsible for this function is Raul A. Pino, P. L. S.

### Background

MIAMI INTERNATIONAL DISTRIBUTION CENTER (T-23230)

- Located in Section 35, Township 53 South, Range 39 East
- Zoning: IU-1
- Proposed Usage: Warehouses with office space
- Number of parcels: 8
- This plat meets concurrency

### Plat Restrictions

- That the Avenues and Lanes, as illustrated on the plat, together with all existing and future planting, trees, shrubbery, and fire hydrants thereon are hereby dedicated to the perpetual use of the public for proper purposes, reserving to the dedicators, their successors and assigns the reversion or reversions thereof, whenever discontinued by law.

- That individual wells shall not be permitted within this subdivision, except for swimming pools, sprinkler systems and/or air conditioners.
- That the use of septic tanks will not be permitted within this subdivision, unless approved for temporary use, in accordance with County and State regulations.
- That all new electric and communication lines, except transmission lines, within this subdivision, shall be installed underground.

**Developer's Obligation**

- None, all improvements are in place.

RESOLUTION NO. R-677-13

RESOLUTION APPROVING THE PLAT OF MIAMI INTERNATIONAL DISTRIBUTION CENTER, LOCATED IN THE NORTHWEST 1/4 OF SECTION 35, TOWNSHIP 53 SOUTH, RANGE 39 EAST (BOUNDED ON THE NORTH BY NW 21 LANE, ON THE EAST BY NW 133 AVENUE, ON THE SOUTH APPROXIMATELY 600 FEET NORTH OF NW 17 STREET, AND ON THE WEST APPROXIMATELY 460 FEET EAST OF NW 137 AVENUE)

WHEREAS, KTR Miami I, LLC, a Delaware limited liability company, and KTR Miami II, LLC, a Delaware limited liability company, have this day presented to this Board a plat of certain lands lying in Miami-Dade County, Florida, said plat to be known as MIAMI INTERNATIONAL DISTRIBUTION CENTER, the same being a replat of Lots 4 through 6, inclusive, of Block 1, and Lot 1, Lots 5 through 8, inclusive, and Lots 12 through 14, inclusive, of Block 6, of "Pan American West Business Park", according to the plat thereof, as recorded in Plat Book 167, at Page 15, of the Public Records of Miami-Dade County, Florida, lying and being in the Northwest 1/4 of Section 35, Township 53 South, Range 39 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said plat insofar as the authority of this Board is concerned have been complied with,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that said plat is hereby approved; that the dedication of the streets, alleys and other rights-of-way however designated or depicted on said plat is hereby accepted; that the Miami-Dade County Plat Restrictions as listed on said plat are approved and are to be enforced; that approval of the plat is not a waiver of any

zoning regulations and that the requirements of the zoning existing on this land at the time this Resolution is approved shall be enforced whether or not the various parcels on this plat conform to those requirements; this approval is conditioned upon the proper execution of all documents required by the County Attorney's Office.

The foregoing resolution was offered by Commissioner **Sen Javier D. Souto**, who moved its adoption. The motion was seconded by Commissioner **Sally A. Heyman** and upon being put to a vote, the vote was as follows:




