

Subject: Resolution approving the Plat for SAN IGNACIO OAKS

Recommendation

The following plat is hereby submitted for consideration by the Board of County Commissioners for approval. This plat is bounded on the north by San Ignacio Avenue, on the east approximately 150 feet west of Trionfo Street, on the south by SW 72 Street, and on the west approximately 800 feet east of Nervia Street. The Miami-Dade County Plat Committee, comprised of representatives from the Florida Department of Transportation, the Florida Department of Health, the Miami-Dade County School Board and Miami-Dade County Departments of Fire Rescue, Parks, Recreation and Open Spaces, Regulatory and Economic Resources (RER), Public Works and Waste Management (PWWM), and Water and Sewer, recommends approval and recording of this plat.

Scope

This plat is located within the boundaries of Commission District 7, Commissioner Xavier L. Suarez.

Fiscal Impact/Funding Source

If this plat is approved, the fiscal impact to the County would be approximately \$50.00 per year for the annual maintenance cost of sidewalks and drainage facilities along SW 72 Street adjacent to the project which will be funded through PWWM General Fund allocation.

Track Record/Monitor

RER, Development Services Division administers the processing of plats and waivers of plat, and the person responsible for this function is Raul A. Pino, P. L. S.

Background

SAN IGNACIO OAKS (T-23319)

- Located in Section 30, Township 54 South, Range 41 East
- Zoning: RU-1
- Proposed Usage: Single family residences
- Number of parcels: 4
- This plat meets concurrency

Plat Restrictions

- That the Street, as illustrated on the plat, together with all existing and future planting, trees, shrubbery, and fire hydrants thereon is hereby dedicated to the perpetual use of the public for proper purposes, reserving to the dedicators, their successors and assigns the reversion or reversions thereof, whenever discontinued by law.
- That individual wells shall not be permitted within this subdivision, except for swimming pools, sprinkler systems and/or air conditioners.



- That the use of septic tanks will not be permitted on any lot within this subdivision, unless approved for temporary use, in accordance with County and State regulations.
- That the utility easements, depicted by dashed lines on the plat, are hereby reserved for the installation and maintenance of public utilities.

Developer's Obligation

- Mobilization, clearing embankment, sidewalks, drainage, traffic control signs, landscaping and monumentation. Bonded under bond number 7877 in the amount of \$25,445.00.

RESOLUTION NO. R-847-13

RESOLUTION APPROVING THE PLAT OF SAN IGNACIO OAKS, LOCATED IN THE SOUTHWEST 1/4 OF SECTION 30, TOWNSHIP 54 SOUTH, RANGE 41 EAST (BOUNDED ON THE NORTH BY SAN IGNACIO AVENUE, ON THE EAST APPROXIMATELY 150 FEET WEST OF TRIONFO STREET, ON THE SOUTH BY SW 72 STREET, AND ON THE WEST APPROXIMATELY 800 FEET EAST OF NERVIA STREET)

WHEREAS, RRE Development, LLC, a Florida limited liability company, has this day presented to this Board a plat of certain lands lying in Miami-Dade County, Florida, said plat to be known as SAN IGNACIO OAKS, the same being a replat of Lot 6, Block 220, of “Revised Plat of Coral Gables Riviera Section Part 13”, according to the plat thereof, as recorded in Plat Book 28, at Page 30, of the Public Records of Miami-Dade County, Florida, and a subdivision of a portion of land, all lying and being in the Southwest 1/4 of Section 30, Township 54 South, Range 41 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said plat insofar as the authority of this Board is concerned have been complied with,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that said plat is hereby approved; that the dedication of the streets, alleys and other rights-of-way however designated or depicted on said plat is hereby accepted; that the Miami-Dade County Plat Restrictions as listed on said plat are approved and are to be enforced; that approval of the plat is not a waiver of any zoning regulations and that the requirements of the zoning existing on this land at the time this Resolution is approved shall be enforced whether or not the various parcels on this plat conform

to those requirements; this approval is conditioned upon the proper execution of all documents required by the County Attorney's Office.

The foregoing resolution was offered by Commissioner **Xavier L. Suarez**, who moved its adoption. The motion was seconded by Commissioner **Rebeca Sosa** and upon being put to a vote, the vote was as follows:
