RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE PARKS, RECREATION AND OPEN SPACES DEPARTMENT FOR THE AUGUST 10, 2013 "FUN DAY BACK TO SCHOOL 2013" EVENT SPONSORED BY CURLEY'S HOUSE OF STYLE, INC. IN AN AMOUNT NOT TO EXCEED \$2,430.00 TO BE FUNDED FROM THE BALANCE OF THE DISTRICT 3 FY 2012-13 IN-KIND RESERVE FUND

WHEREAS, Curley's House of Style, Inc. has requested in-kind services from the Parks, Recreation and Open Spaces Department for the August 10, 2013 "Fun Day Back to School 2013" event in an amount not to exceed \$2,430.00 (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, Curley's House of Style, Inc. is a not-for profit organization; and

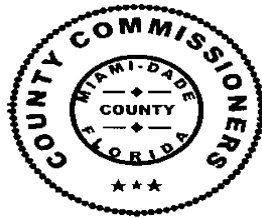



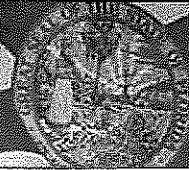
