RESOLUTION DIRECTING THE MAYOR OR DESIGNEE TO
DEVELOP AND MAINTAIN A WEB PORTAL SITE
PROVIDING INFORMATION REGARDING ANNEXATIONS
AND INCORPORATIONS

WHEREAS, the Annexation and Incorporation Task Force has recommended (recommendation No. 19) that the County develop a web portal site providing certain information regarding annexations and incorporations,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that:

Section 1. The Mayor or designee is directed to develop and regularly update a web portal site to include frequently asked questions and answers, principles, and pamphlets relating to the incorporation and annexation process, as well as a listing of active incorporations, annexations, and unincorporated areas of Miami-Dade County.

Section 2. The web portal site shall be launched no later than sixty (60) days of the effective date of this resolution.

The Prime Sponsor of the foregoing resolution is Commissioner Sally A. Heyman and the Co-Sponsor is Vice Chair Lynda Bell. It was offered by Commissioner **Sally A. Heyman**, who moved its adoption.
