RESOLUTION NO. R-66-14

RESOLUTION DIRECTING THE COUNTY MAYOR OR  
MAYOR'S DESIGNEE TO RESEARCH ENROLLMENT OF  
DIABETIC CHILDREN IN PREKINDERGARTEN PROGRAMS  
AND TO REPORT BACK TO THE BOARD OF COUNTY  
COMMISSIONERS WITH PROPOSED RECOMMENDATIONS  
FOR AVOIDING DISCRIMINATION AND FACILITATING  
ENROLLMENT OF DIABETIC CHILDREN IN  
PREKINDERGARTEN PROGRAMS

**WHEREAS**, according to the Centers for Disease Control and Prevention, diabetes is one of "the most common and chronic diseases in children and adolescents"; and

**WHEREAS**, The Miami Herald recently reported that an investigation of 75 prekindergarten programs in Broward County found approximately a third of providers advised they had no space for a diabetic child while advising parents of children without diabetes that they had space; and

**WHEREAS**, The Miami Herald recently reported that the American Diabetes Association and Southern Poverty Law Center are seeking a federal probe by the Justice Department's Civil Rights Division to look at whether Florida prekindergarten programs regularly discriminate against diabetic children; and

**WHEREAS**, prekindergarten programs provide a valuable service to parents; and

**WHEREAS**, parents of children with diabetes should be able to enroll their children in prekindergarten programs,

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA**, that this Board directs the County Mayor or Mayor's designee to research whether prekindergarten centers in Miami-Dade County turn down diabetic children for enrollment when space is available, and to bring a report,

which shall include proposed recommendations for preventing discrimination and facilitating enrollment of diabetic children in prekindergarten programs in Miami-Dade County, for review by this Board within ninety (90) days of the adoption of this item.

The Prime Sponsor of the foregoing resolution is Chairwoman Rebeca Sosa. It was offered by Commissioner **Xavier L. Suarez**, who moved its adoption. The motion was seconded by Commissioner **Lynda Bell** and upon being put to a vote, the vote was as follows:
