

RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE PARKS, RECREATION AND OPEN SPACES DEPARTMENT FOR THE NOVEMBER 9, 2013 "INTERNATIONAL FOOD FESTIVAL" SPONSORED BY COMMUNITY BIBLE BAPTIST CHURCH, INC. IN AN AMOUNT NOT TO EXCEED \$650.00 TO BE FUNDED FROM THE BALANCE OF THE DISTRICT 9 FY 2013-14 IN-KIND RESERVE FUND

WHEREAS, Community Bible Baptist Church, Inc. has requested in-kind services from the Parks, Recreation and Open Spaces Department for the November 9, 2013 "International Food Festival" in an amount not to exceed \$650.00 (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, the purpose of the "International Food Festival" is to, among other things, unify the community through a food festival and promote economic development; and

WHEREAS, Community Bible Baptist Church, Inc. is a not-for-profit organization; and

WHEREAS, the "International Food Festival" is a small event, as that term is defined in the attached Fee Waiver/In-kind Service Application, and \$650.00 of the in-kind services shall be funded from the balance of the District 9 FY 2013-14 In-Kind Reserve Fund,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board retroactively authorizes in-kind services from the Parks, Recreation and Open Spaces Department for the November 9, 2013 "International Food Festival" sponsored by Community Bible Baptist Church, Inc. in an amount not to exceed \$650.00 to be funded from the balance of District 9 FY 2013-14 In-Kind Reserve Fund.


