

Recommendation

It is recommended that the Board of County Commissioners (Board) approve the attached resolution ratifying the Mayor's execution of Florida Inland Navigation District Grant Agreement No. ICW-DA-13-03 with the Florida Inland Navigation District to provide Miami-Dade County with \$20,000.00 for the removal of eleven (11) derelict vessels from Biscayne Bay in the vicinity of Dinner Key Marina.

Scope

Under this agreement, derelict vessel removal occurred in Commission District 7 (Commissioner Suarez).

Fiscal Impact/Funding Source

This Florida Inland Navigation District Grant Agreement (Attachment A) will provide \$20,000.00 toward the total cost of \$41,000.00 to remove eleven (11) derelict vessels from Biscayne Bay in the vicinity of Dinner Key Marina. The remaining \$21,000.00 will be paid from the Biscayne Bay Environmental Enhancement Trust Fund, as approved by Resolution No. R-517-11 (Attachment B) for removal of derelict vessels from Biscayne Bay. No additional impacts due to receipt of these funds are anticipated.

Track Record/Monitor

The Coastal & Wetlands Resources Section Manager, Lisa Spadafina, within the Department of Regulatory and Economic Resources, Division of Environmental Resources Management (DERM), is responsible for implementing these activities.

Background

The Miami-Dade County Derelict Vessel Removal Program, administered through DERM, conducts the removal of abandoned boats and related marine debris from within Biscayne Bay and its tidal tributaries. Removal of these vessels and debris eliminates hazards to public safety, navigation and the environment and enhances the aesthetic quality of the County's coastlines and waterways.


DERM works cooperatively with State and local law enforcement and the US Coast Guard to identify derelict vessels and, when possible, to have them removed by their owners. When a vessel owner cannot be located or fails to remove a vessel in a timely manner, DERM arranges for the vessel's removal and disposal using contractors selected via a competitive bidding process. This program has been funded through a variety of sources, including federal and state grants and the Biscayne Bay Environmental Enhancement Trust Fund. The Florida Inland Navigation District has previously provided grant funds to Miami-Dade County for the removal and disposal of derelict vessels from navigable waterways.

In late 2013, eleven (11) derelict vessels were identified by the City of Miami Police Department Marine Patrol Unit and DERM in the vicinity of Dinner Key Marina. Bids for the removal and disposal of these vessels were requested from five pre-approved vendors and bids ranged from \$41,000.00 to

\$105,400.00. The attached Florida Inland Navigation District Grant Agreement No. ICW-DA-13-03 will provide \$20,000.00 toward Miami-Dade County's contracted costs of \$41,000.00 to remove the eleven (11) derelict vessels.

Miami-Dade County submitted a grant application for partial funding of the removal of these derelict vessels to the Florida Inland Navigation District on November 13, 2013. All eleven (11) of the derelict vessels were removed and disposed in November and December of 2013. The Florida Inland Navigation District determined that the removal of these derelict vessels was eligible for grant funding and the attached grant agreement was executed on January 27, 2014. Miami-Dade County has invoiced the State for reimbursement of the \$20,000.00 from the Florida Inland Navigation District. If the grant had not been awarded, all funding would have come from the Biscayne Bay Environmental Enhancement Trust Fund.

Resolution No. R-1170-06 (Attachment C) authorizes the execution of grants and agreements without prior Board approval when certain criteria are met. The attached grant agreement met the criteria for execution and is hereby submitted to the Board for ratification.

RESOLUTION RATIFYING THE MAYOR'S EXECUTION OF A FLORIDA INLAND NAVIGATION DISTRICT GRANT AGREEMENT TO PROVIDE \$20,000.00 TO MIAMI-DADE COUNTY FOR THE PURPOSE OF REMOVING AND DISPOSING OF ABANDONED AND DERELICT VESSELS LOCATED IN BISCAYNE BAY PURSUANT TO RESOLUTION NO. R-1170-06; AUTHORIZING THE MAYOR OR MAYOR'S DESIGNEE TO EXPEND THESE FUNDS; AND AUTHORIZING THE MAYOR OR MAYOR'S DESIGNEE TO EXECUTE ANY NECESSARY AMENDMENTS TO THE AGREEMENT

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference; and

WHEREAS, abandoned and derelict vessels pose significant hazards to the public and to the environment, and negatively impact the aesthetics of coastlines and waterways; and

WHEREAS, the Florida Inland Navigation District Grant Agreement No. ICW-DA-13-03 provides \$20,000.00 to Miami-Dade County for the removal and disposal of eleven (11) abandoned and derelict vessels located within the Biscayne Bay Aquatic Preserve in the vicinity of Dinner Key Marina in the City of Miami, thereby eliminating these navigational and environmental hazards and improving the physical appearance of the surrounding area; and

WHEREAS, Resolution No. R-1170-06 authorizes the Mayor to apply for, accept and execute grants on the County's behalf without prior County Commission approval when certain terms are met, subject to periodically submitting such grant agreements to this Board for ratification; and

WHEREAS, the Florida Inland Navigation District Grant Agreement No. ICW-DA-13-

03 met the terms set forth in Resolution No. R-1170-06, was signed by the Mayor and fully executed on January 27, 2014, and is hereby submitted to the Board for ratification,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board ratifies the Mayor's execution of Florida Inland Navigation District Grant Agreement No. ICW-DA-13-03 to provide \$20,000.00 to Miami-Dade County for the purpose of removing and disposing of eleven (11) abandoned and derelict vessels located within the Biscayne Bay Aquatic Preserve in the vicinity of Dinner Key Marina; authorizes the Mayor or Mayor's designee to expend these funds; and authorizes the Mayor or Mayor's designee to execute any necessary amendments to the agreement.

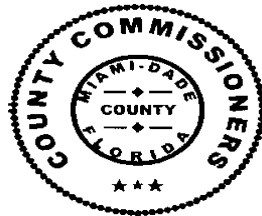

ATTACHMENT A

SMALL-SCALE DERELICT VESSEL REMOVAL

PROJECT AGREEMENT

ICW-DA-13-03

This Agreement is entered into this 27 day of January, 2014 by and between the FLORIDA INLAND NAVIGATION DISTRICT ("FIND") and MIAMI-DADE COUNTY (the "Project Sponsor"). Nothing contained herein shall constitute a waiver by either party of its sovereign immunity under Section 768.28 Florida Statutes.

WHEREAS, Project Sponsor has requested that FIND provide a portion of the funding needed for a Small-Scale Derelict Vessel Removal Project in Miami-Dade County, as detailed in Exhibit A; and

WHEREAS, FIND is willing to provide such assistance for the removal of eligible derelict vessel(s) along the Intracoastal Waterway in Miami-Dade County, subject to the terms and provisions of this Agreement.

NOW, THEREFORE, in consideration of the mutual promises and covenants contained herein, the parties hereby agree as follows:

1. Subject to the provisions of this Agreement, Project Sponsor shall coordinate the work for the Project. Project Sponsor agrees, with respect to the Project, that as between the parties to this Agreement, it shall be solely responsible for any claims for damages resulting therefrom. Project Sponsor agrees to indemnify FIND, its Commissioners, employees, and agents, from any and all liabilities, claims, costs, damages, and expenses (including court costs and attorneys' fees) arising from or related to Project Sponsor's actions regarding the Project.

2. FIND shall provide an amount not to exceed \$20,000 for the components of the project set forth in Exhibit A, with FIND paying the Project Sponsor up to seventy-five percent (75%) of the amount actually expended for each component, up to the amount listed on Exhibit A for said component, which shall also be in compliance with the District's policy on Small-Scale Derelict Vessel Removal projects Exhibit C.

3. The funds to be provided by FIND to the Project Sponsor hereunder will be paid within thirty (30) days of receipt by FIND of a request for payment accompanied by supporting documentation showing expenditures equal or greater to the amount being sought from FIND.

4. The Project Sponsor, upon completion of the PROJECT, shall submit to the DISTRICT a request for final reimbursement of the PROJECT AMOUNT less any prior installment payments. The Payment amounts previously retained by the DISTRICT shall be paid upon (1) receipt of the Final Audit report of expenses incurred on the PROJECT by the DISTRICT, (2) full completion of the PROJECT to the reasonable satisfaction of the DISTRICT, (3) submission of Project Completion Certification Form No. 90-13 (Exhibit B), and (4) submission of a photograph(s) of the completed PROJECT(s).

5. Project Sponsor shall, upon request by FIND, provide a report of final expenses incurred on the Project. The Project Sponsor shall also retain all records supporting costs of the Project for three (3) years after the end of the fiscal year in which the Project is completed, except that such records shall be retained by Project Sponsor until final resolution of matters resulting from any litigation, claim, or special audit that starts prior to the expiration of the three-year retention period.

6. If Project Sponsor shall fail to fulfill in a timely and proper manner the obligations under this Agreement, or if Project Sponsor shall violate any of the covenants, terms, or stipulations of this Agreement, FIND shall thereupon have the rights to terminate this Agreement.

Notwithstanding the above, Project Sponsor shall not be relieved of liability for damages or expenses as contemplated herein sustained by FIND by virtue of any breach of the Agreement by Project Sponsor.

7. Any notice or other written communications between Project Sponsor and FIND shall be considered delivered when posted by certified mail or delivered in person to the respective party at the address indicated below (see next page):

8. This instrument embodies the entire agreement of the parties. There are no provisions, terms, conditions or obligations other than those contained herein; and this Agreement shall supersede all previous communication, representation or agreements, either verbal or written between the parties hereto. This Agreement shall not be modified unless in writing and signed by both parties hereto.



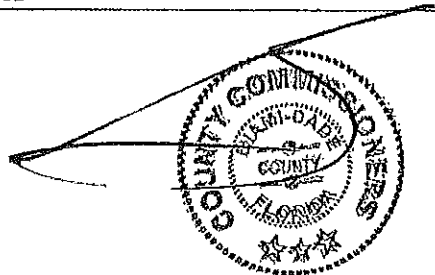

Exhibit C

Small-Scale Derelict Vessel Removal Projects Rule (Rule 66B-2.015)

Proposals shall be accepted for financial assistance for the removal of derelict vessels within the District's waterways. The applicable provisions of this rule apply to these applications with the following additions or exceptions:

(1) Application Procedure – Applications shall be submitted on a completed FIND Form No. 05-01 (Small-Scale Derelict Vessel Removal Program) (effective date 4-24-06), and FIND Form No. 01-06 (Small-Scale Derelict Vessel Removal Program – Project Cost Estimate), (effective date 4-24-06), hereby incorporated by reference and available from the District office. Applications may be submitted to the District and considered by the Board at any time during the year.

(2) The District shall only fund applicants that have identified derelict vessels to be removed and have a current bid for removal for such vessels, or have completed the removal of such vessels within the 6 months preceding the application, subject to eligibility under these program rules.

(3) The program must be sponsored by an eligible government agency or not-for-profit organization.

(4) District funding shall be limited to \$20,000.00 per county, per year, provided on a reimbursement basis only. The limitation on pre-agreement expenses may be waived by the Board in accordance with subsection 66B-2.005(3), F.A.C.

(5) The eligible applicant must provide the remaining matching funds for project completion. In no case shall the District's cost-share contribution exceed 75% of the total project costs. In-house project management or administration costs are not eligible costs or matching costs.

(6) The derelict vessel must be located in the District's Waterways, as defined in Rule 66B-2.003, F.A.C. The applicant shall include a map clearly delineating the location of all vessels included in the application.

(7) The District shall be recognized when possible in all written, audio or video advertising and promotions as a participating sponsor of the program.

(8) The funding provided by the District shall only be allocated for removal of derelict vessels. The District is providing program reimbursement funds only and shall be held harmless with regards to the activities initiated by the applicant.

(9) The applicant shall be responsible for all maintenance, management, disposal and operating expenses associated with the program.

(10) Funds derived from the sale of any derelict vessels or vessel parts removed through this grant program must be reinvested into the applicant's derelict vessel removal program.

(11) The District Board shall make all final decisions concerning the provision of funding for this program.

Subject: Resolution Authorizing the Disbursement of \$400,000 from the Biscayne Bay Environmental Enhancement Trust Fund to Conduct Environmental Enhancement in Biscayne Bay through the Miami-Dade County Biscayne Bay Restoration and Enhancement Program

Recommendation

It is recommended that the Board of County Commissioners approve the attached resolution authorizing the disbursement of \$400,000 from the Biscayne Bay Environmental Enhancement Trust Fund (BBEETF) for bay island trash and solid waste removal, derelict vessel and marine debris removal, bay environmental restoration, habitat maintenance and biological monitoring in connection with the ongoing County's Biscayne Bay Restoration and Enhancement Program.

Scope

This disbursement request will benefit coastal areas of Commission Districts 3, 4, 5, 7, 8, and 9.

Fiscal Impact/Funding Source

This resolution authorizes the disbursement of funds from the BBEETF for Biscayne Bay restoration and maintenance activities. This BBEETF disbursement is consistent with the BBEETF Ordinance codified in Section 24-40 of the Code of Miami-Dade County (Code) that allows BBEETF funds to be used for the restoration and enhancement of Biscayne Bay and its foreshore. Index Code: TFDE400010, Subobject: 22430, available balance: \$534,000 as of March 31, 2011 (pending disbursements have been subtracted).

Track Record/Monitor

The Director of the Department of Environmental Resources Management (DERM) will monitor the activities performed with the BBEETF funds. The activities include all project-related tasks including overall program administration, outside funding requests and agreements, contractor selection, contract administration, restoration contract compliance, success monitoring, and final reporting.

Background

As part of the Biscayne Bay Restoration and Enhancement Program, DERM conducts various environmental restoration and enhancement activities throughout Biscayne Bay. These highly successful and popular projects are generally implemented on public lands and are assisted financially through state and federal funding programs such as the South Florida Water Management District, the Florida Inland Navigation District and the National Oceanographic and Atmospheric Administration.

The project agreements between Miami-Dade County and the funding agencies require long-term activities by DERM at previously restored sites such as the wetlands restoration projects at Virginia Key, Chapman Field and Oleta River State Park. Activities include routine trash and solid waste removal, supplemental plantings, exotic vegetation control, and biological monitoring. This disbursement request will provide funding for a two-year period for the removal and disposal of bay island trash and solid waste (\$180,000), the removal of derelict vessels and marine debris (\$150,000), the planting of native wetland plants and the monitoring of plant survival (\$30,000) and the control of exotic plants (\$40,000). These restoration activities will be conducted by County staff and by outside contractors under a later competitive bidding process.

Subject: Recommendation for Disbursement of \$400,000 from the Biscayne Bay Environmental Enhancement Trust Fund to Conduct Environmental Enhancement in Biscayne Bay through the Miami-Dade County Biscayne Bay Restoration and Enhancement Program

Pursuant to Section 24-40 of the Code of Miami-Dade County, I am recommending the disbursement of \$400,000 from the Biscayne Bay Environmental Enhancement Trust Fund (BBEETF) for maintenance and monitoring at environmental restoration areas pursuant to project agreements between Miami-Dade County and various funding partners. The project agreements require long-term activities conducted by DERM at previously restored sites, such as the wetlands restoration projects at Virginia Key, Chapman Field and Oleta River State Park, in connection with the County's ongoing Biscayne Bay Restoration and Enhancement Program.

The coastal environments in Biscayne Bay face many challenges and threats to their present and future health. This disbursement request will provide funding for a two-year period for the removal and disposal of bay island trash and solid waste (\$180,000), the removal of derelict vessels and marine debris (\$150,000), the planting of native wetland plants and the monitoring of plant survival (\$30,000) and the control of exotic plants (\$40,000).

These restoration activities will be conducted by County staff and by outside contractors, to be determined by a later competitive bidding process.

The \$400,000 requested to be disbursed are encumbered BBEETF monies that were deposited into the BBEETF for the purpose of restoration and enhancement of Biscayne Bay and its foreshore. The proposed activities are consistent with the goals and intent of the Biscayne Bay Environmental Enhancement Trust Fund Ordinance as codified in Section 24-40 of the Code of Miami-Dade County.

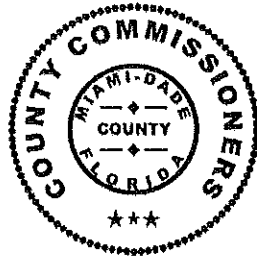

WHEREAS, the Board passed Resolution No. 730-06 granting authority to the County Manager to apply for, accept and execute grants on the County's behalf without County Commission approval when certain criteria were met; and

WHEREAS, one of the criteria is that the funds provided under the grant be less than \$2,000.00; and

WHEREAS, most of the grants applied for by the County do not meet this criteria; and

WHEREAS, the monetary criteria should be increased to allow for more grants to fall under the County Manager's purview to expedite the grant application process,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that the County Manager is hereby delegated authority to apply for, accept and execute grants on the County's behalf without prior County Commission approval provided that: 1) the amount of funds provided under the grant is less than \$100,000.00; 2) the grant is for a single department; 3) the grant does not require the provision of a new funds to match the grant funds; 4) the terms of the grant will not hinder another department or the County from seeking other funds; and 5) the granting agency does not require County Commission approval. The County Manager shall periodically submit grant agreements executed under the authority of this resolution to this Board for ratification.

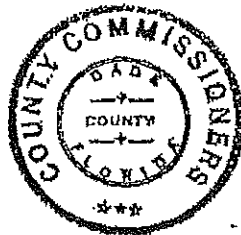
