RESOLUTION NO. R-268-14

RESOLUTION CODESIGNATING NW 87 AVENUE FROM NW 138 STREET TO NW 154 STREET AS "ROYAL LAKES BOULEVARD"; APPROVING THE TOWN OF MIAMI LAKES CODESIGNATION OF NW 87 AVENUE FROM NW 154 STREET TO NW 170 STREET AS "ROYAL LAKES BOULEVARD"

WHEREAS, on February 11, 2014 the Town Council of the Town of Miami Lakes adopted Resolution No. 14-1171 which urged the Miami-Dade County Board of County Commissioners to codesignate NW 87 Avenue from NW 138 Street to NW 170 Street as "Royal Lakes Boulevard", a copy of which is attached and incorporated by reference; and

WHEREAS, the neighborhoods of "Royal Gardens", "Royal Oaks", "Royal Palm Estates", and "West Lakes Estates" are located along or near NW 87 Avenue; and

WHEREAS, this codesignation will support the Town of Miami Lakes effort to unify these neighborhoods; and

WHEREAS, NW 87 Avenue from NW 138 Street to NW 154 Street is a County road located with the Town of Miami Lakes, and NW 87 Avenue from NW 154 Street to NW 170 Street is a Town of Miami Lakes road; and

WHEREAS, the Town of Miami Lakes wants the County to install signage indicating this codesignation on County street signs and traffic signal masts arms; and

WHEREAS, this codesignation is located in County Commission District 13,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Having considered this matter at a public hearing, codesignates NW 87 Avenue from NW 138 Street to NW 154 Street as "Royal Lakes Boulevard."

Section 2. Approves the Town of Miami Lakes codesignation of NW 87 Avenue from NW 154 Street to NW 170 Street as "Royal Lakes Boulevard."

Section 3. Directs the Clerk of the Board to send certified copies of this Resolution to the Town Manager of the Town of Miami Lakes, the United States Postal Service, the Traffic Signals and Signs Division of the Public Works and Waste Management Department, the Development Services Division of the Regulatory and Economic Resources Department, the Miami-Dade Police Department, and the Miami-Dade Fire Rescue Department.

The Prime Sponsor of the foregoing resolution is Commissioner Esteban L. Bovo, Jr. It was offered by Commissioner Esteban L. Bovo, Jr. , who moved its adoption. The motion was seconded by Commissioner José "Pepe" Diaz and upon being put to a vote, the vote was as follows:

RESOLUTION NO. 14- 1171

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA URGING THE MIAMI-DADE COUNTY BOARD OF COUNTY COMMISSIONERS TO CO-DESIGNATE NW 87TH AVENUE AS "ROYAL LAKES BOULEVARD;" AUTHORIZING TOWN OFFICIALS TO TAKE ALL STEPS NECESSARY TO CO-DESIGNATE THE ROAD; DIRECTING THE CLERK TO PROVIDE A COPY OF THIS RESOLUTION TO THE MIAMI-DADE COUNTY BOARD OF COUNTY COMMISSIONERS AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Town of Miami Lakes ("the Town") includes the neighborhoods commonly known as "Royal Gardens," "Royal Oaks," "Royal Palm Estates," and "West Lakes Estates;" and

WHEREAS, these neighborhoods are located along or near NW 87th Avenue; and

WHEREAS, this Council proposes to co-designate N.W. 87th Avenue, between NW 138th Street and NW 170th Street, as "Royal Lakes Boulevard;" and

WHEREAS, this co-designation will support the Town's efforts to unify these neighborhoods; and

WHEREAS, N.W. 87th Avenue is a Miami-Dade County road located within the boundaries of the Town of Miami Lakes;

WHEREAS, this proposed co-designation is located within Miami-Dade County Commission District 13; and

WHEREAS, this Council desires to recognize and unify these neighborhoods by urging the Miami-Dade County Commission to authorize this co-designation; and

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL FOR THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The foregoing recitals are true and correct and are incorporated herein by reference.

Section 2. This Council urges the Miami-Dade County Board of County Commissioners to co-designate N.W. 87th Avenue , between NW 138th Street and NW 170th Street, as "Royal Lakes Boulevard."

Section 3. Authorization of Town Officials. The Town Manager and/or his designee and the Town Attorney are authorized to take all actions necessary to implement this Resolution.


Section 4. Direction to Clerk. The Town Clerk is directed to send a certified copy of this resolution to the Honorable Esteban L. Bovo, Jr., District 13 Commissioner for his consideration of sponsorship of a resolution co-designating that portion of NW 87th Avenue, between NW 138th Street and NW 170th, as "Royal Lakes Boulevard."

Section 5. Effective Date. This Resolution shall be effective immediately upon adoption.

Passed and adopted this 11th day of February, 2014.




