

Subject: Resolution approving the Plat of 6491 SNAPPER CREEK COURT

Recommendation

The following plat is hereby submitted for consideration by the Board of County Commissioners for approval. This plat is bounded on the north by SW 84 Street, on the east approximately 400 feet west of SW 64 Avenue, on the south by SW 85 Street, and on the west by SW 65 Avenue. The Miami-Dade County Plat Committee, comprised of representatives from the Florida Department of Transportation, the Florida Department of Health, the Miami-Dade County School Board and Miami-Dade County Departments of Fire Rescue, Parks, Recreation and Open Spaces, Regulatory and Economic Resources (RER), Public Works and Waste Management (PWWM), and Water and Sewer, recommends approval and recording of this plat.

Scope

This plat is located within the boundaries of Commission District 7, Commissioner Xavier L. Suarez.

Fiscal Impact/Funding Source

If this plat is approved, the fiscal impact to the County would be approximately \$100.00 per year for the annual maintenance cost of the additional new road pavement and drainage structures for SW 65 Avenue, and new drainage structures for SW 84 and 85 Streets, respectively, once constructed adjacent to the project which will be funded through PWWM General Fund allocation.

Track Record/Monitor

RER, Development Services Division administers the processing of plats and waivers of plat, and the person responsible for this function is Raul A. Pino, P. L. S.

6491 SNAPPER CREEK COURT (T-23294)

- Located in Section 36, Township 54 South, Range 40 East
- Zoning: EU-M
- Proposed Usage: Single family residences
- Number of parcels: 4
- This plat meets concurrency

Plat Restrictions

- That the Avenue and Streets, as illustrated on the plat, together with all existing and future planting, trees, shrubbery and fire hydrants thereon, are hereby dedicated to the perpetual use of the public for proper purposes, reserving to the dedicators, their successors and assigns the reversion or reversions thereof, whenever discontinued by law.
- That individual wells shall not be permitted within this subdivision, except for swimming pools, sprinkler systems and/or air conditioners.
- That the use of septic tanks will not be permitted on any lot within this subdivision, unless approved for temporary use, in accordance with County and State regulations.
- That all new electric and communication lines, except transmission lines, within this subdivision, shall be installed underground.

Developer's Obligation

- Paving, drainage, mobilization, clearing, milling, resurfacing, traffic control signs, striping and monumentation. Bonded under bond number 7892 in the amount of \$41,934.00.

RESOLUTION NO. R-313-14

RESOLUTION APPROVING THE PLAT OF 6491 SNAPPER CREEK COURT, LOCATED IN THE SOUTHWEST 1/4 OF SECTION 36, TOWNSHIP 54 SOUTH, RANGE 40 EAST (BOUNDED ON THE NORTH BY SW 84 STREET, ON THE EAST APPROXIMATELY 400 FEET WEST OF SW 64 AVENUE, ON THE SOUTH BY SW 85 STREET, AND ON THE WEST BY SW 65 AVENUE)

WHEREAS, Big Molar, LLC, a Florida limited liability company, has this day presented to this Board a plat of certain lands lying in Miami-Dade County, Florida, said plat to be known as 6491 SNAPPER CREEK COURT, the same being a replat of Lots 5 and 6, Block 3, of “Snapper Creek Groves”, according to the plat thereof, as recorded in Plat Book 44, at Page 88, of the Public Records of Miami-Dade County, Florida, lying and being in the Southwest 1/4 of Section 36, Township 54 South, Range 40 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said plat insofar as the authority of this Board is concerned have been complied with,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that said plat is hereby approved; that the dedication of the streets, alleys and other rights-of-way however designated or depicted on said plat is hereby accepted; that the Miami-Dade County Plat Restrictions as listed on said plat are approved and are to be enforced; that approval of the plat is not a waiver of any zoning regulations and that the requirements of the zoning existing on this land at the time this Resolution is approved shall be enforced whether or not the various parcels on this plat conform

to those requirements; this approval is conditioned upon the proper execution of all documents required by the County Attorney's Office.

The foregoing resolution was offered by Commissioner **Rebeca Sosa** who moved its adoption. The motion was seconded by Commissioner **Sally A. Heyman** and upon being put to a vote, the vote was as follows:


