RESOLUTION NO. R-362-14

RESOLUTION URGING CONGRESS TO ENACT THE COUNTERING ALBA ACT OF 2013, H.R. 1687 OR SIMILAR LEGISLATION THAT WOULD DIRECT THE PRESIDENT TO IMPOSE SANCTIONS AGAINST CERTAIN OFFICIALS OF THE GOVERNMENTS OF VENEZUELA, NICARAGUA, BOLIVIA, AND ECUADOR OR PERSONS ACTING ON BEHALF OF THOSE GOVERNMENTS WHOM THE PRESIDENT DETERMINES ARE RESPONSIBLE FOR, OR COMPLICIT IN, THE COMMISSION OF SERIOUS HUMAN RIGHTS ABUSES

WHEREAS, on April 23, 2013, Congresswoman Ileana Ros-Lehtinen filed H.R. 1687 which would urge the President to sanction officials of the governments of Venezuela, Nicaragua, Bolivia, and Ecuador or anyone acting on behalf of those governments whom the President has determined to be responsible for, or complicit in, ordering, controlling, or otherwise directing, the commission of serious human rights abuses against citizens of those countries; and

WHEREAS, on March 4, 2014, the County condemned the Venezuelan government for using violence and intimidation against its opposition, and urged the federal government to take immediate diplomatic action to help return democracy and the rule of law to Venezuela, pursuant to Resolution No. R-253-14 which is attached and incorporated by reference; and

WHEREAS, there have also been reports of human rights violations by the governments of Nicaragua, Bolivia, and Ecuador; and

WHEREAS, as part of the United States government's diplomatic efforts to address the pressing and escalating situation in Venezuela, this Board believes that sanctions should be imposed upon the Venezuelan officials responsible for human rights violations, including Nicolas Maduro,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Urges Congress to enact the Countering ALBA Act of 2013, H.R. 1687 or similar legislation that would direct the President to impose sanctions against certain officials of the governments of Venezuela, Nicaragua, Bolivia, and Ecuador, or persons acting on behalf of those governments whom the President determines are responsible for, or complicit in, the commission of serious human rights abuses.

Section 2. Directs the Clerk of the Board to transmit a certified copy of this resolution to the members of the Florida Congressional Delegation, U.S. Representative Ileana Ros-Lehtinen, and U.S. Representative Albio Sires.

Section 3. Directs the County's federal lobbyists to advocate for the passage of the legislation as set forth in Section 1 above, and authorizes and directs the Office of Intergovernmental Affairs to amend the 2014 Federal Legislative Package to include this item.



RESOLUTION NO. R-253-14

RESOLUTION CONDEMNING THE VENEZUELAN GOVERNMENT FOR USING VIOLENCE AND INTIMIDATION AGAINST ITS POLITICAL OPPOSITION; EXPRESSING SUPPORT FOR THOSE VENEZUELAN WHO ARE VALIANTLY FIGHTING TO RESTORE THEIR NATION TO A PEACEFUL AND DEMOCRATIC STATE; URGING THE FEDERAL GOVERNMENT TO TAKE IMMEDIATE DIPLOMATIC ACTION

WHEREAS, Nicolás Maduro—a member of the United Socialist Party—was declared the winner of Venezuela’s April 14, 2013 presidential election by an incredibly slim margin with 50.6 percent of votes cast; and

WHEREAS, Venezuela’s political opposition has highlighted widespread incidents of potential election fraud, voter intimidation, and other abuses by the Venezuelan government in support of Nicolás Maduro’s candidacy; and

WHEREAS, the Organization of American States and other multilateral institutions have called for a full recount and audit of the April 14, 2013 presidential election; and

WHEREAS, the Senate of the Republic of Chile, the Christian Democratic Organization of the Americas, the Socialist International, the Union of Latin American parties, and other political organizations in the region have issued declarations recognizing the possibility of election irregularities and have also urged a complete audit of the election results; and

WHEREAS, Venezuela’s National Electoral Council has nevertheless denied requests for a full and comprehensive audit of the election results; and

WHEREAS, the people of Venezuela have a right to a fair and democratic process and their government has an obligation to promote and defend it; and

WHEREAS, this right was usurped by the Venezuelan government during the April 14, 2013 presidential election and has continued to be infringed by the government's sustained actions against its political opposition; and

WHEREAS, for example, opposition parties in Venezuela were denied the right to speak in the national legislature from April 16, 2013 to May 21, 2013 and members from those parties were removed from key committee positions in response to raising concerns over the legitimacy of the presidential election results; and

WHEREAS, members of the United Socialist Party of Venezuela also violently assaulted opposition legislators on April 16, 2013 and April 30, 2013 in the National Assembly; and

WHEREAS, the Venezuelan government's rampant disregard for the free speech rights of its citizens has only persisted; and

WHEREAS, in recent weeks, the Venezuelan people have begun to courageously take to the streets in nationwide protests against President Maduro; and

WHEREAS, the Venezuelan government has responded to these protests with violent acts of repression, human rights violations, killing individuals who are doing nothing more than exercising their right to free speech, and arresting various members of the political opposition, including opposition leader Leopoldo López; and

WHEREAS, the Venezuelan government also recently expelled three U.S. diplomats from the country; and

WHEREAS, these are not the actions of a nation that purports to be democratic and governed by the rule of law; and

WHEREAS, the U.S. Senate has already passed S.Res.213, which urges the State Department to work in concert with other countries in the Americas to take meaningful steps to

ensure the rule of law in Venezuela and to strengthen the ability of the Organization of American States to respond to election fraud and human rights violations by its member states; and

WHEREAS, this Board believes that the United States government should employ all available diplomatic options to address the pressing and escalating situation in Venezuela,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Condemns the Venezuelan government for using violence and intimidation against its political opposition.

Section 2. Expresses its support for those Venezuelans who are valiantly fighting to restore their nation to a peaceful and democratic state.

Section 3. Urges the federal government to take immediate diplomatic action to help return democracy and the rule of law to Venezuela.

Section 4. Directs the Clerk of the Board to transmit a certified copy of this resolution to the members of the Florida Congressional Delegation, the Secretary of State, and the United States Ambassador to the Organization of American States.
