RESOLUTION NO. R-394-14

RESOLUTION DEPICTING COMMUNITY COUNCIL AND SUBAREA BOUNDARIES AS SET FORTH IN ATTACHED MAPS RATHER THAN BY REFERENCE TO VOTING PRECINCTS; MODIFYING BOUNDARIES OF COMMUNITY COUNCILS AND SUBAREAS TO REFLECT CERTAIN ANNEXATIONS; DIRECTING COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO PUBLISH MAPS ON THE WEBSITE

WHEREAS, Section 20-42(C) of the Code of Miami-Dade County provides that the boundaries of Community Councils and the subareas within them may be amended from time to time by resolution of the County Commission after public hearing; and

WHEREAS, the boundaries of Community Councils and subareas have previously been defined by reference to the voting precincts contained within them; and

WHEREAS, defining Community Councils and subareas by precincts rather than actual maps requires that such Community Councils and subareas be amended whenever the voting precincts are changed; and

WHEREAS, this Board, in accordance with Section 20-42 of the Code of Miami-Dade County desires to define the boundaries by maps rather than reference to voting precincts, and make certain modification to Community Council and subarea boundaries as a result of certain annexations; and

WHEREAS, maps delineating the boundaries of Community Councils and subareas are on file with the Clerk of the Board and the Department of Regulatory and Economic Resources,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that the Board, in accordance with Section 20-42(C) of the Code of Miami-Dade County hereby approves the Community Council and subarea boundaries as set forth in the maps on file with the Clerk of the Board, which are incorporated herein by reference, and as indicated in the composite Attachment 1. The Board further directs the County Mayor or County Mayor's designee to publish maps depicting the boundaries of the Community Councils and subareas on the County's website.

The Prime Sponsor of the foregoing resolution is Chairwoman Rebeca Sosa. It was offered by Commissioner **Audrey Edmonson**, who moved its adoption. The motion was seconded by Commissioner **Rebeca Sosa** and upon being put to a vote, the vote was as follows:
