Subject: Resolution approving the Plat of NERY SUBDIVISION

Resolution No. R-396-14

Recommendation

The following plat is hereby submitted for consideration by the Board of County Commissioners for approval. This plat is bounded on the north approximately 230 feet south of NW 6 Street, on the east approximately 300 feet west of NW 120 Avenue, on the south approximately 600 feet north of NW 2 Street, and on the west by NW 122 Avenue. The Miami-Dade County Plat Committee, comprised of representatives from the Florida Department of Transportation, the Florida Department of Health, the Miami-Dade County School Board and Miami-Dade County Departments of Fire Rescue, Parks, Recreation and Open Spaces, Regulatory and Economic Resources (RER), Public Works and Waste Management (PWWM), and Water and Sewer, recommends approval and recording of this plat.

Scope

This plat is located within the boundaries of Commission District 12, Commissioner Jose "Pepe" Diaz.

Fiscal Impact/Funding Source

If this plat is approved, the fiscal impact to the County would be approximately \$200.00 per year for the annual maintenance cost of the new road construction for NW 4 Terrace once the road is constructed within the project, which will be funded through PWWM General Fund allocation.

Track Record/Monitor

RER, Development Services Division administers the processing of plats and waivers of plat, and the person responsible for this function is Raul A. Pino, P. L. S.

Background

NERY SUBDIVISION (T-23316)

- Located in Section 1, Township 54 South, Range 39 East
- Zoning: EU-M
- Proposed Usage: Single family residences
- Number of parcels: 6
- This plat meets concurrency

Plat Restrictions

- That the Terrace and Avenue, as illustrated on the plat, together with all existing and future planting, trees, shrubbery and fire hydrants thereon, are hereby dedicated to the perpetual use of the public for proper purposes, reserving to the dedicators, their successors and assigns the reversion or reversions thereof, whenever discontinued by law.
- That individual wells shall not be permitted within this subdivision, except for swimming pools, sprinkler systems and/or air conditioners.
- That the use of septic tanks will not be permitted on any lot within this subdivision, unless approved for temporary use, in accordance with County and State regulations.
- That all new electric and communication lines, except transmission lines, within this subdivision, shall be installed underground.
- That the utility easements, depicted by dashed lines on the plat, are hereby reserved for the installation and maintenance of public utilities.

Developer's Obligation

- Paving, drainage, mobilization, clearing, sidewalk, valley gutter, street name signs, traffic control signs, striping, detectable warning surfaces, guardrail and monumentation. Bonded under bond number 7895 in the amount of \$99,393.00.

RESOLUTION NO. R-396-14

RESOLUTION APPROVING THE PLAT OF NERY SUBDIVISION, LOCATED IN THE NORTHEAST 1/4 OF SECTION 1, TOWNSHIP 54 SOUTH, RANGE 39 EAST (BOUNDED ON THE NORTH APPROXIMATELY 230 FEET SOUTH OF NW 6 STREET, ON THE EAST APPROXIMATELY 300 FEET WEST OF NW 120 AVENUE, ON THE SOUTH APPROXIMATELY 600 FEET NORTH OF NW 2 STREET, AND ON THE WEST BY 122 AVENUE)

WHEREAS, FVP Development, LLC, a Florida limited liability company, has this day presented to this Board a plat of certain lands lying in Miami-Dade County, Florida, said plat to be known as NERY SUBDIVISION, the same being a replat of Lots 16, 17, and 18, Block 4, of “Sweetwater Estates”, according to the plat thereof, as recorded in Plat Book 28, at Page 36, of the Public Records of Miami-Dade County, Florida, lying and being in the Northeast 1/4 of Section 1, Township 54 South, Range 39 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said plat insofar as the authority of this Board is concerned have been complied with,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that said plat is hereby approved; that the dedication of the streets, alleys and other rights-of-way however designated or depicted on said plat is hereby accepted; that the Miami-Dade County Plat Restrictions as listed on said plat are approved and are to be enforced; that approval of the plat is not a waiver of any zoning regulations and that the requirements of the zoning existing on this land at the time this Resolution is approved shall be enforced whether or not the various parcels on this plat conform

to those requirements; this approval is conditioned upon the proper execution of all documents required by the County Attorney's Office.

The foregoing resolution was offered by Commissioner **Lynda Bell**, who moved its adoption. The motion was seconded by Commissioner **Sally A. Heyman** and upon being put to a vote, the vote was as follows:
