**Recommendation**

This Recommendation for Award for Construction Contract No. 2008-032.04 between JVA Engineering Contractor, Inc. and Miami-Dade County has been prepared by PortMiami and is recommended for approval for a total contract amount of \$6,196,835.57.

**Delegation of Authority** - The authority of the County Mayor or County Mayor's designee to execute and implement this contract is consistent with those authorities granted under the Code of Miami-Dade County. Additional delegation of authorities requested for this contract are as follows:

The General Conditions for the Contract, Article 42, "Disputes," Section B states that any and all disputes shall be decided by the Contracting Officer. The contract stipulates that the Contracting Officer for this contract is the Director of the Miami-Dade Seaport Department and/or his/her designee.

This multiphase improvement project consists of upgrading existing utility infrastructure and pavement for approximately eight (8) acres to improve the efficiency of cargo operations. The area within this phase of the project will primarily be used for heavy equipment and container storage. In addition, the improvements in this phase will consist of the following, but are not limited to: mobilization/demobilization; installation of new high mast lighting; electrical conduits; utility adjustments; improvements to pavement, existing drainage, and the water system; earthwork and related operations.

**EXPLANATION:** The project was advertised on February 27, 2014. Ten bids were received on April 1, 2014. The base bid amounts ranged between approximately \$5.48 Million and \$7.93 Million (excluding allowance accounts). The lowest bid, in the amount of \$5,483,925.28 was submitted by JVA Engineering Contractor, Inc. (JVA) and was found to be the lowest responsive and responsible bidder. In addition, JVA's bid was found compliant with the Community Small Business Enterprise (CSBE) measures, established for this solicitation; 10.56%.

The base estimate included within the Request to Advertise, \$6,815,711.77, was revised during the bidding process by Parsons Brinckerhoff, Inc. the Engineer of Record (EOR). The revised base estimate includes plan modifications as required by Miami-Dade County's (County) Water and Sewer Department and Fire Rescue Department, to increase the size of the water main along with changes to ancillary structures. Therefore, the revised base estimate, \$6,852,402.83, is 1% higher than the original base estimate. As a result, the base bid amount

submitted by JVA is 19.54% below the original base estimate and 19.97% below the revised base estimate.

Local preference was not applicable as the lowest bidder, JVA, is a locally headquartered firm; therefore, Best and Final offers were not required.

The bids were reviewed by PortMiami staff and the apparent low bidder, JVA, was found to be responsive and responsible to all bid requirements. Furthermore, the EOR reviewed the bids and provided a written statement, attesting that the low bid was reasonable and competitive. In addition, at PortMiami's request, JVA provided written confirmation that their firm will provide the required services included in the Bid Documents for the price provided in their bid.

Pursuant to Resolution R-187-12, and in accordance with the Internal Services Department's Procurement Guidelines, PortMiami staff exercised due diligence to determine the Contractor's responsibility. The lists that were referenced include: Sun Biz, Dun & Bradstreet, convicted vendors, debarred vendors, delinquent contractors, suspended vendors and federal excluded parties. There were no adverse findings relating to the Contractor's responsibility. In addition, as part of the award process, PortMiami staff compiled information regarding JVA's prior experience with County. There are twenty-three (23) evaluations listed in the Capital Improvements Information System with an average score of 3.4 out of a possible 4.0 points. In addition, JVA's principal has indicated 12 years' experience as a general contractor in construction work similar to the work for this contract. Finally, PortMiami staff reviewed the business references included in JVA's bid package and deemed their experience for projects similar in size and complexity satisfactory. Therefore, PortMiami recommends this contract be awarded to JVA, a CSBE firm.



The Contractor agrees to make payment of all proper charges for labor and materials required in the aforementioned work, and to defend, indemnify and save harmless Miami-Dade County and all its officers and agents against and from all suits and costs of every kind and description, and from all damages to which the said Miami-Dade County or any of its officers and agents may be put, by reason of injury or death to persons or injury to property of others resulting from the performance of said work, or through the negligence of the Contractor, or through any improper or defective machinery, implements or appliances used by the Contractor in the aforesaid work, or through any act or omission on the part of the Contractor, or his agent or agents, employees or servants.

The Contractor agrees that the requirements of this contract are reasonable and achievable.

The Contractor further agrees that the Rates of Wages for all laborers, mechanics and apprentices employed by the Contractor or any Subcontractor shall be not less than the prevailing rate of wages for similar skills or classifications, all in accordance with Section 215.19, Florida Statutes, which said Section is hereby incorporated into this Contract by reference, or in accordance with the decision of the Secretary of Labor of the United States Department of Labor, as applicable and all provisions thereof shall be strictly complied with by the Contractor and his Subcontractors.

In consideration of the premises, Miami-Dade County hereby agrees to pay to the Contractor for said work, when fully completed, the total sum of Six Million, One hundred Ninety Six Thousand, Eight Hundred Thirty Five Dollars and 57/100 (\$6,196,835.57), being the amount obtained from either the aggregate lump sum prices, the application of unit prices to the quantities shown in the Bid Form or the combination of both.

The total sum is subject to such additions and deductions as may be provided for in the Contract Documents.

Payments on account will be made as provided for in the Contract Documents.

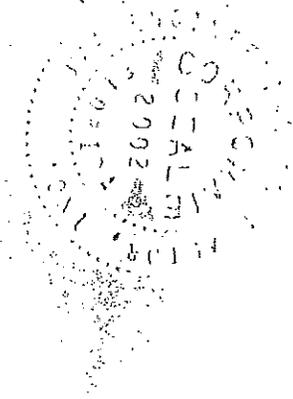

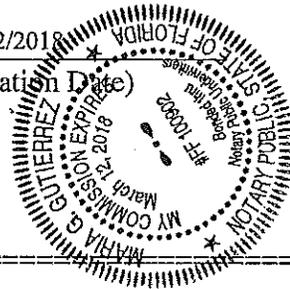
