RESOLUTION NO. R-634-14

RESOLUTION DIRECTING THE COUNTY MAYOR OR MAYOR'S DESIGNEE TO PROVIDE LICENSED SOCIAL WORKERS AND LICENSED MENTAL HEALTH PROFESSIONALS EMPLOYED BY THE COUNTY WITH GRIEF COUNSELING TRAINING AND TO CREATE A GRIEF COUNSELING COMMUNITY PROGRAM TO HELP COMMUNITIES IMPACTED BY MURDER, IN COORDINATION WITH THE MIAMI-DADE COUNTY COMMUNITY RELATIONS BOARD

WHEREAS, a murder committed at a particular location may significantly impact and traumatize members of that ~~[[community]]~~¹ >>community, particularly children<<; and

WHEREAS, in high-crime locations, individuals may benefit from counseling to cope with the trauma of a murder of a >>neighbor,<< ~~[[neighbor-or]]~~ fellow community member >>or a child<<; and

WHEREAS, the Miami-Dade County Community Relations Board is an advisory board whose duties include working "proactively to identify and relieve intergroup conflicts before cris[e]s arise" and "to assure that resources are in place to respond to community crisis[;]" and

WHEREAS, ~~[[Miami Dade County Public Schools has developed a crisis management team of counseling professionals who provide consultation, materials and presentations for school staff and parents on topics such as bullying/harassment, youth suicide and bereavement]]~~
>>school systems throughout the country have programs that provide grief counseling whenever a tragedy impacts their schools<<; and

WHEREAS, employees across different County departments may be licensed social workers and licensed mental health professionals; and

>>WHEREAS, these licensed professionals may be willing to participate in a grief counseling program subject to collective bargaining agreements with labor unions that may apply,<<

~~[[WHEREAS, Miami-Dade County is party to collective bargaining agreements with labor unions; and~~

~~WHEREAS, some County employees who are licensed social workers and licensed mental health professionals may be union members;]]~~

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board directs the County Mayor or Mayor's designee to compile a list of licensed social workers and licensed mental health professionals employed by the County, to provide >>participating<< licensed social workers and licensed mental health professionals already employed by the County with training in >>community<< grief counseling, and in accordance with the provisions of any applicable labor union agreements, to develop a Grief ~~[[Assistance Coalition]]~~ >>Counseling Community Program similar to the Goodwill Ambassadors Program,<< comprised of the County's licensed social workers and licensed mental health professionals to help communities where murders have taken place, in coordination with the Miami-Dade County Community Relations Board.

The Prime Sponsor of the foregoing resolution is Commissioner Dennis C. Moss and the Co-Sponsor is Vice Chair Lynda Bell. It was offered by Commissioner **Sally A. Heyman**, who moved its adoption. The motion was seconded by Commissioner **Dennis C. Moss** and upon being put to a vote, the vote was as follows:
